INTRODUCED BY COUNCILMEMBER TREVA REID

**RESOLUTION AMENDING RESOLUTION NO. 88780 C.M.S., WHICH AMONG OTHER THINGS GRANTED SEVENTY-FIVE THOUSAND DOLLARS (\$75,000) TO HOMIES EMPOWERMENT, TO ADD SOCIAL GOOD FUND INC. AS FISCAL SPONSOR FOR HOMIES EMPOWERMENT.**

**WHEREAS**, on July 21, 2021 the Oakland City Council adopted Resolution No. 88780 C.M.S., which among other things, awarded a grant in the amount of Seventy-Five Thousand Dollars (\$75,000) to Homies Empowerment for community-related services; and

**WHEREAS**, Homies Empowerment is a nonprofit engaged in community services that requires a fiscal sponsor; and

**WHEREAS**, Social Good Fund Inc. has agreed to be a fiscal sponsor for Homies Empowerment; now, therefore, be it

**RESOLVED:** That Resolution No. 88780 C.M.S. is amended to add Social Good Fund Inc. as fiscal sponsor for Homies Empowerment as indicated below in *bold italicized* typeset:
