

Lake Merritt Parking Community Engagement Survey (Responses)

Oakland Impact Center surveyed 2,400 people at Lake Merritt over the course of the following dates: 4/23/2022,4/24/2022, 4/30/2022, 5/1/2022, 5/6/2022, 5/7/2022, and 5/8/2022





General unedited comments from survey participants

How can the City see these actions as fair, how did they reach this decision. Why is Oakland using San Francisco tactics. What message does the City believe this proposal gives to residents and lake goers. Is it too late to make changes to this approach?

It taxes those who already feel marginalized without clear direction we know the history of the City and those in power never follow through on the promises made to the people. Keep the parking free and finds ways to generate money that can benefit the marginalized individuals. Put meters in the hills and more affluent communities and let those taxes go towards programs and services that help folks to become self-sufficient.

We need to stop this it's another attack on the people. I'm sure other larger cities have figured out other ways to keep people from paying. It's unfair and sends a strong statement against keep the lake accessible for all.

This is an attack on Black's in particular

This process should help to manage parking and allow others to enjoy the Lake keeping a flow of on the amount of time that's spent in one location.

Why is the City forcing parking meters as a response to parking. This will not decrease parking or deal with traffic it will only cost people and the funds will not appropriately go where they should.

There's something unsettling about the license plate readers seems a bit extreme to provide parking tickets.

It continues to show the disconnect between community and government agencies we must figure a way to have discussions allowing community input to guide the process exposing wherexposing where potential funds already exist within the general fund.

Not in support of

Shame on the City for thinking this a good idea this is a push out knowing that people are not for it and will mush rather see inclusive processes that show care and concern for Black Oakland.

Residents concerned about how they will be affected if they don't have off street parking

Longtime resident feared this would take away from city's culture

Everyone strongly disagreed with proposal and also voiced concern with car burglaries/vandalism in the area as well

Already too many attacks on Blacks in Oakland this is our City and I'm not in support of this proposal.

Why now? The City is greedy! This is a form of track and herding people.

This a blatant and aggressive approach to depopulating the Lake people from all backgrounds chill and enjoy this space. Don't take away the beauty of the Lake by changing and charging. Is this a last minute Libby bad idea as she's on her way out? Why are the citizens and residents being forced to pay to spend time at the Lake what gives them the right to push this on the people. Do they honestly believe that we think this is beneficial to the City and not its people. We would have this info or our voices heard if y'all wasn't bringing it to us. Somebody from. The City should have been out here making it a true proposal that includes the thoughts of the people who this is projected at.

We park over here and support the vendors and chill with the family why are we being forced to pay or leave. What are the alternatives to this parking proposal? Why haven't they put multiple options on the table that generates funds and not be limited to just this option?

It's greedy to push parking on Lakeshore. We can only assume that the more people are out here the higher the rates will be. This stinks not a smart thing to do. Who will this ultimately benefit? This definitely feels restrictive on free space. They should survey residents and merchants and people that come here all the time to see how will folks are for other forms of taxing that has the potential to build more funds

than this metering system being proposed. When is the City going to use the greatness of its own citizens to put forth ideas that can include items that we can build consensus on? I don't support the meters and City Council will here about this.

Why were we not made aware of this before

How can we impact this moving forward. Who can we talk to directly about this?

We have questions before we feel comfortable making a judgement on this.

If this can really help then I'm all for it but I don't really trust the city to do what it says it will do.

We've followed this from the beginning and thinks it's a great idea especially with the funding it can produce to help other parks and give everyone equal access at the lake.

This is just the city of Oakland doing something that wont benefit the original people from Oakland and it's another money grab.

We don't trust the city and the process to benefit most people.

Love the idea about putting funding towards other part but we have no trust in city officials to do what they say they will do.

Can we join the next meeting about this decision? How?

This wont work. It may benefit some people but it wont benefit most.

How can we be sure about where the funding goes?

I'm a lake neighbor and I think this will benefit everyone.

Why are we just getting informed of this. We don't trust the city.

Who is going to control the meters and the pricing? This seems like another money grab.

This could be good but only if they do everything exactly as they say they will. Its hard to believe they will do that because of the history of the city.

I've lived by the lake for 10 years and we need some solutions. I really hope this works.

I am a long-time Oakland resident who is born and raised in the Bay Area, a proud product of Peralta Colleges, and former employee of OUSD. I also worked for 5 years at the American Indian Child Resource Center in Oakland, which is located right on the lake at Grand and Euclid. I am currently a PhD student at UC Berkeley in the History department. I walk the lake everyday and spend time hanging out at the lake just about every weekend. To put meters around the lakeshore side of the lake would be a direct act against working class people like myself who would be unable to continue to enjoy our beautiful lake if it meant paying every time that I wanted to walk or hang out there. Thus, I am strongly opposed to meters being put up at the lake and take it as a direct slap in the face to me and the community that I represent. A community who has suffered enough from the impact of "development" and gentrification and who feel squeezed out of the city that we love at every turn. This is only one small way in which the leadership of this community can show that they have any desire to put people over profit, a gesture that seems to be happening less and less every year.

We are so tired of the city doing things like this with community input. How are we suppose to trust a process that we get left out of?

We feel like parking has gotten much better. We don't feel like this is needed at all.

Need more information about who is behind this decision and project?

License plate reader's that will automatically generate tickets, fees that are at a higher rate when more people are present. If a car pulls over to take a call a pull off shortly after pulling over it that person assessed a ticket even though the parking was only for a few moments? How does meters enforcement parking or safety or deal with all the unsafe driving?

The City needs to do something to manage the flow of people and put order to the madness and hazardous driving that show up here daily. They should be metered parking around the entire Lake to include Lakeshore Avenue

Need more info

I'm not from Oakland but I do understand why they would charge to be out here

If it improves the lake features more accessible bathrooms im for it if it's just another money grab Either is has a say in it

The area should be accessible for residents!

Residents should NOT have to pay for parking at a public park

I don't think it's needed and if we have to download a app for it who keeps the data

I'm all for it maybe people won't park in the middle of the streets if they're going to enforce parking

Don't do it! The lake is for the people! Keep it real!

Parking meters by the lake will diswade low income people from coming to the lake.

This is currently a place where everyone has a welcome. If there are parking meters by the lake less low income people will feel welcome here. That is messed up!

Parking as it is in area is a hassle

The parking meters are the latest in the concerted attempts to move people who have been using this community space out and further gentrify the lake. At this time, when public spaces are few and far between, we should be doubling down on making these spaces accessible to everyone. There is no reason to institute these parking meters. They do not make people safer, and there are plenty of other ways to raise revenue in the City of Oakland. Car break ins will happen regardless of whether there are parking meters and parking enforcement. The people of Oakland have already given up so much, we need everyone to rally behind not taking away one of the remaining spaces for people of all income levels and cultures to meet and come together. I strongly oppose this move as a resident of Oakland.

If the funds are going to city parks and improvements I'm for it

As a resident it might keep the streets clear for my visitors

Not in support of any form of oppressive tactics and this is gentrification and racist. They ate proposing to place them exactly where all the black are. The City is not using those who are brilliant enough to find other ways to implement parcels taxes or use funds from general purpose funds or solicit private foundation funds to support the programs and services listed in the document. We have no evidence that the City will appropriately allocate the funds what we have seen is them misappropriate funds or flat out lie about how the funds should be used and or are located.

This is all about money.

Why does this city always do this? Makes these huge changes without the community involved.

What city official are doing this? Is there another meeting coming up about this that we could attend and voice our opinion?

We believe if people would actually know what this is about, they would really be supportive. We also know the people who are putting this together and we really trust their leadership.

Maybe the parking meter can help with reporting and dealing with all the stolen cats that at abandoned here all the time. I've called and reported the cars at in most cases it takes the City at least 3 weeks or more to remove them. Maybe this plate reader will help notify law enforcement of the stolen and abandoned vehicles along Lakeshore.

I'm from Santa Rosa I come here often with friends and park along Lakeshore mostly I don't agree with this proposal at all.

The meters are not the answer to the parking situation having some community body that's not law enforcement to assist with managing people and building agreements that make sense for the safety of everyone.

Meters can't communicate with the people that's what's needed more than pushing people out or creating fees that reduce the amount of time people spend.

We walk the lake a few times a week and park on Lakeshore all the time for the free parking it is not the business side of the lake more residential and open space why take that from people vote no on the proposed parking meters.

If funds are raised then services can support the many concerns at the Lake.

Those funds will never get to the services they will become lost in the belly of the beast...

The Lake should have received funds from reimagining public safety task force being that the lake has so many issues being such a public attraction.

Yes the city has a responsibility to allocate funds from other sources that don't include taxing the people.

This proposal is disrespectful and is not the answer to resolving parking, dealing with safety for pedestrians, who benefits from this? I sure know who suffers behind it us blacks. As a father of four I'm looking for something to do that don't cost. What about inflation and outrageous cost of living? Why are those factors not included in this proposal?

It's a big no on this proposal to put parking meters that are connected solely to ATM cards or banking institutions is simply discrimination and against the law

Parking meters are not the answer to managing traffic and sideshow activity unsafe driving and the gathering of people. Please rethink this plan and include community input because is affects us.

Why are we being targeted for gathering and accessing public space. The City should ad an additional tax for all the high rise buildings that are popping up all over the place tax all the former sf residents moving downtown tax all those who can afford it.

This is public space one of the few neutral places that we can bring our kids that we don't have to worry about something happening. Although people have been killed here those are isolated incidents that don't reflect how peaceful this are is.

That lake is beautiful adding parking meters to Lakeshore will make it ugly for some people.

I live over here and already struggling paying rent this proposal is thoughtless damaging the trust and confidence in the City.

If it happens I wouldn't be surprised

Say if we don't move what's the penalty

This is a great plan. It will help with a lot of the stolen cars that are abandoned around her and it will make people share the parking which will allow more people to visit our beautiful lake, Thats how it supposed to be.
