

Resolution Declaring the Results of the City of Oakland General Municipal *E*lection held on Tuesday, November 2, 2010

WHEREAS, pursuant to law and Section 1101 of the Charter of the City of Oakland, a General Municipal Election was duly and regularly held in the City of Oakland on Tuesday, November 2, 2010; and

WHEREAS, pursuant to Section 1105 of the Charter of the City of Oakland, the ballots in the races for Mayor and Councilmember of District 4 were tabulated using Ranked Choice Voting because no single candidate received a majority in the first round of voting; and

WHEREAS, the results stated below in the races for Mayor and Councilmember of District 4 reflect the final tally after the Ranked Choice Voting tabulation was conducted; and

WHEREAS, the City Clerk has canvassed the election returns of said consolidated election pursuant to law; and


