RESOLUTION NO. C.M.S.

INTRODUCED BY COUNCILMEMBER DAN KALB

RESOLUTION IN SUPPORT OF PROPOSITION 30, THE CLEAN AIR INITIATIVE, WHICH WOULD INCREASE THE TAX ON PERSONAL INCOME ABOVE \$2 MILLION BY 1.75% FOR TWENTY YEARS AND DEDICATE THE REVENUE TO ZERO-EMISSION VEHICLE SUBSIDIES, ZERO-EMISSION VEHICLE INFRASTRUCTURE, AND WILDFIRE SUPPRESSION AND PREVENTION PROGRAMS.

WHEREAS, the City of Oakland is committed to becoming a more sustainable city – a community in which all people have the opportunity to pursue safe, happy, healthy and fulfilling lives, now and into the future; and

WHEREAS California is increasingly experiencing extreme heatwaves, relentless droughts, and record-setting wildfires that ruin our air quality, damage California's iconic natural beauty, destroy property, hurt our state's economy, and cost lives; and

WHEREAS 38 million of California's population of 39+ million residents breathe polluted air, and the American Lung Association gives 31 of California's 58 counties an F in air quality; and

WHEREAS, Oakland is particularly vulnerable to wildfires, having experienced a deadly wildfire in 1991 that took 25 lives and injured 150 others; and

WHEREAS Black and Brown Californians are 61 percent more likely than white residents to live in a county with a failing grade for air quality, according to the American Lung Association; and

WHEREAS California is not on track to meet our climate goals, namely the reduction of our overall heat-trapping greenhouse gas emissions (GHGs) to 40% below 1990 levels by 2030; and

WHEREAS in order to achieve the state's carbon goals and avoid the worst impacts of climate change, action is needed now to curb the two biggest sources of GHGs in our state: transportation and wildfires, which are both an outcome and a primary cause of climate change; and

WHEREAS current state and federal programs, including the Inflation Reduction Act, are needed progress but do not provide enough resources for California to reach its climate goals,

therefore, Prop 30 is needed to work in tandem with those programs to do so. While the IRA provides \$14 billion in zero-emissions vehicle (ZEV) incentives to the entire country over ten years, Prop 30 provides \$80 to \$100 billion in ZEV incentives to California alone over 20 years; and

WHEREAS transitioning our transportation system to zero-emission light-, medium-, and heavy-duty vehicles is one of the most effective way to restore California's clean air; and

WHEREAS California Governor Gavin Newsom issued an executive order requiring all new cars and passenger trucks sold in California be ZEVs by 2035; and

WHEREAS California cannot likely meet these ZEV goals, our broad climate goals, or federally mandated air quality standards without a generational, scaled investment in zero-emission transportation. Existing state and federal programs are simply not enough; and

WHEREAS the passage of Proposition 30 will generate roughly \$80 to \$100 billion in sustained investment for California over the next 20 years, including \$20 billion to fight and prevent wildfires, \$45 billion for subsidies to help consumers and organizations afford ZEVs, and \$35 billion to expand ZEV charging infrastructure; and

WHEREAS Proposition 30 requires that at least half of its funding for the vehicle and infrastructure investments (or approximately \$40+ B) benefit low-income residents and disadvantaged communities; and

WHEREAS the funding source of Proposition 30 — a small 1.75% tax increase on personal income in excess of \$2 million — affects only 0.2% of Californians and ensures the revenue comes from those most able to afford it and not from families already struggling with California's high cost of living; and

WHEREAS The City of Oakland is committed to advancing healthy, sustainable, and equitable communities; and be it

RESOLVED that City of Oakland supports the passage of Proposition 30 at the 2022 November State General Election.
