RESOLUTION NO. 89400 2 C.M.S.

INTRODUCED BY VICE MAYOR KAPLAN, COUNCIL PRESIDENT FORTUNATO BAS, COUNCIL PRO TEMPORE THAO & COUNCILMEMBER FIFE

RESOLUTION IN SUPPORT OF PROPOSITION 1, WHICH, IF PASSED BY THE VOTERS IN THE GENERAL ELECTION ON NOVEMBER 8, 2022, WOULD AMEND THE CALIFORNIA CONSTITUTION TO EXPRESSLY PROVIDE THAT THE STATE SHALL NOT DENY OR INTERFERE WITH AN INDIVIDUAL'S REPRODUCTIVE FREEDOM, WHICH INCLUDES THEIR FUNDAMENTAL RIGHT TO CHOOSE TO HAVE AN ABORTION AND THEIR FUNDAMENTAL RIGHT TO CHOOSE OR REFUSE CONTRACEPTIVES

WHEREAS, on June 24, 2022, in a historic and far-reaching decision, *Dobbs v. Jackson Women's Health Organization*, the U.S. Supreme Court reversed *Roe v. Wade*, which guarantees the federal constitutional protection of abortion rights; and

WHEREAS, this rollback on a woman's right to choose to have an abortion has reverberated across the county, both galvanizing communities to denounce the decision and energizing others to impose strict limitations on individuals seeking an abortion; and

WHEREAS, since the Supreme Court's reversal, more than 20 states have restricted access to abortions, imposing criminal sanctions on individuals receiving or performing an abortion, and in some cases, imposing civil offenses against any person who aids or abets a person from receiving an abortion; and

WHEREAS, with this wave of restrictions, Oakland has pushed back against these regressive policies, passing <u>Resolution No. 89201 CMS</u>, which declared Oakland a Right-To-Choose Sanctuary City; and

WHEREAS, access to reproductive health care should not depend on your zip code, and people should be able to access the reproductive health care they need without medically unnecessary barriers or restrictions; and

WHEREAS, in addition, health care providers should be able to offer care without interference or fear of being criminalized; and

WHEREAS, reproductive freedom is intertwined with many issues of social justice such as economic, gender, and racial equity; therefore, a strong support system for reproductive freedom measures ensures that Californians of all backgrounds have access to the care they need; and

WHEREAS, Proposition 1, which will be voted on in the November 2022 election, will allow individuals and families to continue to have the freedom to determine what is best for them and their families, giving people the ability to plan their lives and make important reproductive decisions without the government interfering; and

WHEREAS, by expressly stating the right to choose to have an abortion is a fundamental right in the California Constitution, Proposition 1 will also protect against potential future attacks at the federal level and erosion of those rights by the courts; now, therefore, be it

That the Oakland City Council hereby expresses its support for RESOLVED: Proposition 1, which, if passed by the voters in the general election on November 8, 2022, would amend the California Constitution to expressly provide that the State shall not deny or interfere with an individual's reproductive freedom, which includes their fundamental right to choose to have an abortion and their fundamental right to choose or refuse contraceptives.
