THE CITY OF OAKLAND; A PUBLIC ENTITY; THE COUNTY OF ALAMEDA, A PUBLIC ENTITY; CALIFORNIA DEPARTMENT \mathbf{OF} TRANSPORTATION DOING BUSINESS AS ("DBA") CALTRANS; A PUBLIC ENTITY; STATE OF CALIFORNIA, A PUBLIC ENTITY AND DOES 1 THROUGH 20, INCLUSIVE, ALAMEDA COUNTY SUPERIOR COURT CASE NO. RG19046209, CITY ATTORNEY'S FILE NO. 33548, IN THE AMOUNT OF SEVEN HUNDRED FORTY-FIVE THOUSAND DOLLARS AND ZERO CENTS (\$745,000,00) (DEPARTMENT OF TRANSPORTATION -**DANGEROUS CONDITION OF PUBLIC PROPERTY)**

WHEREAS, Plaintiff alleges that on June 20, 2019, they suffered injuries from a bicycle accident wherein their bicycle tire became lodged in a sinkhole on Harrison Street near the intersection of Harrison Street and Moss Avenue in Oakland, due to an alleged dangerous condition of public property; and

WHEREAS, Plaintiff claims they suffered a traumatic brain injury and various orthopedic injuries including a broken clavicle, which required surgery and further medical treatment. Plaintiff also claims a herniated spinal disc resulted in chronic pain and will require a future discectomy surgery; and

WHEREAS, Plaintiff filed Superior Court of the State of California, County of Alameda, Case No. RG19046209 against the City of Oakland, and other parties later dismissed, alleging a claim against the City for dangerous condition of public property; and

WHEREAS, the City has considered all the evidence, litigation costs, and litigation risks in this case; and

WHEREAS, the City admits no wrongdoing or liability; and

WHEREAS, the parties and their legal counsel have negotiated a fair and reasonable settlement of these claims; now, therefore, be it

RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of Sami Jabaji, an individual v. The City of Oakland; a public entity; The County of Alameda, a public entity; California Department of Transportation dba Caltrans; a public entity; State of California, a public entity and DOES 1 - 20, inclusive, Alameda County Superior Court Case No. RG19046209, City Attorney's File No. 33548, for the sum of Seven Hundred Forty-Five Thousand Dollars and Zero Cents (\$745,000.00); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement.
