INTRODUCED BY COUNCILMEMBER FIFE AND VICE MAYOR KAPLAN

RESOLUTION RECOGNIZING THE ENORMOUS IMPORTANCE OF HOLY NAMES UNIVERSITY TO THE OAKLAND COMMUNITY AND URGING THE UNIVERSITY'S ADMINISTRATION TO WORK COLLABORATIVELY WITH FACULTY, STAFF, STUDENTS, ELECTED OFFICIALS, AND COMMUNITY PARTNERS TO RESOLVE THE ISSUES FACING THE INSTITUTION WITH THE GOAL AND INTENTION OF MAINTAINING IT AS AN INSTITUTION OF HIGHER LEARNING AT THE CURRENT SITE TO CONTINUE SERVING THE OAKLAND COMMUNITY

WHEREAS, Holy Names University (HNU), located on Mountain Blvd in Oakland, has been a premier institution for higher learning for over 154 years; and

WHEREAS, since 1868, HNU has been committed to its core values of spiritual and academic cultivation, providing a rigorous yet supportive environment for countless students to thrive; and

WHEREAS, HNU is a life-line for first-generation college students, transfer students and working adults seeking to further their careers and educational goals; and

WHEREAS, in 2019, U.S. News and World Report's Best College guide ranked Holy Names "in the top 10 for Campus Ethnic Diversity and in the top 20 of the guide's new Top Performers on Social Mobility category for Regional Universities West;" and

WHEREAS, nearly 79% of HNU's student body are Black and Brown and many of them are the first in their families to attend college; and

WHEREAS, the education and tutelage provided at HNU is one of a kind—with small classes and supportive faculty, those who have attended the University have gone on to become educators, medical personnel, and community leaders; and

WHEREAS, HNU is currently facing difficult financial issues and in a recent newsletter, the school announced that beginning Fall 2023, HNU will no longer be able to offer an athletics program; and

WHEREAS, due to these financial conditions, HNU is grappling with the possibility of a potential closure or a merger with another institution; and

WHEREAS, it is critical that the quality of education, the diversity, and the overall fabric of the university is maintained; and

WHEREAS, in addressing the issues the University faces, it is important that HNU's administration is openly communicating and collaborating with the HNU community to come up with creative solutions to ensure that higher education continues at the current site; now, therefore, be it

RESOLVED: That the Oakland City Council recognizes the enormous importance of Holy Names University to the Oakland community; and be it

FURTHER RESOLVED: That the City Council urges the Holy Names University administration to work collaboratively with faculty, staff, students, elected officials, and community partners to resolve the issues facing the institution with the goal and intention of maintaining it as an institution of higher learning serving the Oakland Community.
