RESOLUTION AND DIRECTING AUTHORIZING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CASE OF SANDRA PARROTT V. CITY OF OAKLAND, AND DOES 1-25, INCLUSIVE, ALAMEDA COUNTY SUPERIOR COURT CASE NO. RG20063194, CITY ATTORNEY'S FILE NO. 33806, IN THE AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$500,000.00) (DEPARTMENT OF TRANSPORTATION - DANGEROUS CONDITION OF PUBLIC PROPERTY)

WHEREAS, Plaintiff Sandra Parrott allegedly tripped and fell on an uplifted portion of sidewalk on Stanford Avenue on June 5, 2019; and

WHEREAS, the uplift was allegedly caused by the roots of a nearby official City tree; and

WHEREAS, Plaintiff's big right toe was fractured and, after extensive treatment and multiple surgical procedures, was amputated as a result of the fall; and

WHEREAS, Plaintiff filed Sandra Parrott v. City of Oakland, et al., Alameda County Superior Court Case No. RG20063194 against the City of Oakland alleging a dangerous condition of public property, and claiming past and future medical expenses, loss of income, and pain and suffering; and

WHEREAS, without admitting fault or wrongdoing, the City has determined to compromise Plaintiff Parrott's claim for the sum of Five Hundred Thousand Dollars and no Cents (\$500,000.00); now, therefore, be it

RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of Sandra Parrott v. City of Oakland, et al., Alameda County Superior Court Case No. RG20063194, City Attorney's File No. 33806 for the sum of Five Hundred Thousand Dollars and No Cents (\$500,000.00); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement.
