## INTRODUCED BY COUNCIL PRESIDENT NIKKI FORTUNATO BAS

RESOLUTION REAPPOINTING COUNCILMEMBER NOEL GALLO TO THE BOARD OF DIRECTOR OF THE ALAMEDA COUNTY LEAD POISONING PREVENTION PROGRAM JOINT POWERS AUTHORITY AND DIRECTOR WILLIAM GILCHRIST AS THE OFFICIAL ALTERNATE FOR COUNCILMEMBER GALLO FOR TERMS COMMENCING JANUARY 1, 2023 AND ENDING DECEMBER 31, 2024

WHEREAS, lead poisoning can seriously affect a child's brain and nervous system and has been shown to cause learning and behavioral problems that impact a child for the rest of their life; and

WHEREAS, in California, children are exposed to lead through a number of pathways: by ingesting lead-contaminated dust, paint chips from deteriorating lead-based paint, lead-contaminated soil, traditional home remedies, and imported spices, candies, and other food products; from exposure to lead dust brought home on parents' work clothes, certain imported ceramic pottery, and painted objects; and through certain activities that involve lead products such as soldering, making stained glass, and handling bullets or fishing sinkers; and

**WHEREAS**, the City of Oakland has some of the highest rates of childhood lead exposure in the state of California; and

**WHEREAS,** the Alameda County Board of Supervisors passed a resolution officially establishing the Alameda County Healthy Homes Department in 1991 to begin addressing, among other things, childhood lead exposure and lead poisoning; and

WHEREAS, the resolution allowed cities in the County to participate in and support the Program by assessing an annual \$10 fee on all residential dwellings constructed before 1978, the first year that the U.S. Consumer Product Safety Commission (CPSC) banned lead in paint for residential use; and

**WHEREAS**, the Cities of Oakland, Berkeley, and Alameda were the first to participate in the program, and the city of Emeryville joined in 1992; and

WHEREAS, the program is governed by the Joint Powers Authority (JPA) which is composed of elected officials from each participating city, the County of Alameda and a community representative; and

WHEREAS, Councilmember Noel Gallo was appointed in 2021 as Oakland's representative to the Joint Powers Authority for a term commencing April 20, 2021 and ending December 31, 2022; and

WHEREAS, Director of the Department of Building and Planning William Gilchrist was appointed to serve as the official alternate for Councilmember Noel Gallo for a term commencing April 20, 2021 and ending December 31, 2022; and

WHEREAS, Rule 6 of the Council's Rules of Procedure provides that, except for appointments reserved to the Mayor under the City Charter, the Council President shall recommend appointments to regional and local boards and agencies as appropriate subject to confirmation of the City Council; now, therefore be it

**RESOLVED**: That Councilmember Noel Gallo is hereby reappointed to the Lead Poisoning Prevention Program Joint Powers Authority for the term commencing January 1, 2023 and ending December 31, 2024; and be it

**FURTHER RESOLVED**: That Director William Gilchrist is hereby reappointed to serve as the official alternate for Councilmember Noel Gallo for the term commencing January 1, 2023 and ending December 31, 2024.
