**RESOLUTION APPOINTING MEMBERS TO THE OAKLAND-ALAMEDA COUNTY COLISEUM AUTHORITY BOARD OF COMMISSIONERS AS FOLLOWS-APPOINTING COUNCILMEMBER KEVIN JENKINS FOR THE TERM BEGINNING JANUARY 15, 2023 AND ENDING JANUARY 14, 2025 TO THE SEAT PREVIOUSLY HELD BY COUNCILMEMBER TREVA REID AND REAPPOINTING COUNCILMEMBER REBECA KAPLAN FOR THE TERM BEGINNING JANUARY 15, 2023 AND ENDING JANUARY 14, 2025**

**WHEREAS**, Section 4 of the Joint Exercise of Powers Agreement dated December 17, 1996 (Joint Powers Agreement) created the Oakland-Alameda County Coliseum Authority, whose members are appointed by the Oakland City Council and the Alameda County Board of Supervisors to serve two-year terms; and

**WHEREAS**, Section 4 of the Joint Powers Agreement originally provided that the Oakland-Alameda County Coliseum Authority Board of Commissioners would consist of four members, two members of the City Council and two members of the Alameda County Board of Supervisors; and

**WHEREAS**, on February 9, 2001, pursuant to Section 4 of the Joint Powers Agreement, the Board of Commissioners voted to add additional board members with two to be appointed by the City Council from members of the community; and

**WHEREAS**, Rule 6 of the Council's Rules of Procedure provides that, except for appointments reserved to the Mayor under the City Charter, the Council President shall recommend appointments to regional and local boards and agencies as appropriate subject to confirmation of the City Council; now, therefore be it

**RESOLVED:** That Councilmember Kevin Jenkins is hereby appointed to the Oakland-Alameda County Coliseum Authority Board of Commissioners for the term beginning January 15, 2023 and ending January 14, 2025 to the seat previously held by Councilmember Treva Reid, and Councilmember Rebecca Kaplan is reappointed for the term beginning January 15, 2023 and ending January 14, 2025.
