

INTRODUCED BY COUNCIL PRESIDENT NIKKI FORTUNATO BAS

RESOLUTION AUTHORIZING REIMBURSEMENT FOR NECESSARY COSTS NOT TO EXCEED \$1,400 EACH FROM THE COUNCIL CONTINGENCY FUND FOR COUNCIL MEMBERS CARROLL FIFE AND TREVA REID TO TRAVEL TO SACRAMENTO FOR ATTENDANCE AT THE LEAGUE OF CALIFORNIA CITIES NEW MAYORS AND COUNCIL MEMBERS ACADEMY FROM JANUARY 18, 2023 THROUGH JANUARY 20, 2023

WHEREAS, Council Members Carroll Fife and Treva Reid will be participating in the League of California Cities New Mayors and Council Members Academy being held in Sacramento CA, on January 18-20, 2023; and

WHEREAS, City Council Resolution No. 82800 C.M.S approved by the City Council on June 1, 2010 requires that when council members seek Council approval for using City funds for travel, their agenda materials shall indicate whether travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees and the source of City funding that will be used to cover the travel cost; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost for Council Members Carroll Fife and Treva Reid is \$625.00 in registration fees, \$500.00 for lodging, and \$237.00 per diem each for a total estimated cost of \$1,362.00 per person, all costs within the City of Oakland's approved travel policies and procedures; and

WHEREAS, Council Members Carroll Fife and Treva Reid seek City Council approval for the aforementioned cost to travel to Sacramento CA, to attend the League of California Cities New Mayors and Council Members Academy being held in Sacramento CA, on January 18-20, 2023; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized in an amount not to exceed \$1400 per person.
