INTRODUCED BY COUNCILMEMBER NOEL GALLO

RESOLUTION AUTHORIZING THE TRAVEL AND REIMBURSEMENT OF NECESSARY EXPENSES FOR COUNCILMEMBER NOEL GALLO'S TRAVEL TO WASHINGTON DC AND ATTENDANCE AT THE NATIONAL LEAGUE OF CITIES' CONGRESSIONAL CITY CONFERENCE FROM MARCH 23, 2023 THROUGH MARCH 29, 2023, IN THE AMOUNT OF \$4,250.00 FOR REGISTRATION FEES, HOTEL, AIR FARE AND PER DIEM FROM THE COUNCIL CONTINGENCY FUND

WHEREAS, Councilmember Noel Gallo is the City of Oakland's Voting Delegate to the National League of Cities, and the League's Congressional City Conference is being held in Washington, DC, on March 24-29, 2023, and;

WHEREAS, City Council Resolution No. 82800 C.M.S approved by the City Council on June 1, 2010, requires that when Councilmembers seek Council approval to use City funds for travel their agenda reports shall indicate whether City funds shall be used when travel involves airline transportation and lodging, shall provide an estimate of the cost of airline, lodging, per diem and conference fees and shall identify the source of City funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated costs for Councilmember Gallo are \$750 in registration fees, \$2,693.00 for lodging, \$553.00 for airfare, and up to \$250.00 per diem, all costs within the City of Oakland's approved travel policies and procedures, and;

WHEREAS, the City Council Contingency Project fund is the source of City funding that will be used to cover these travel costs; and

WHEREAS, Councilmember Noel Gallo seeks City Council approval for the aforementioned cost to travel to Washington, DC and attend the National League of Cities 2022 Congressional City Conference; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.
