**RESOLUTION ACKNOWLEDGING AND THANKING GLORIA BRUCE
FOR HER EXTRAORDINARY WORK AND LEADERSHIP ON
AFFORDABLE HOUSING IN OAKLAND AND THE EAST BAY AS EAST
BAY HOUSING ORGANIZATIONS (EBHO) EXECUTIVE DIRECTOR**

WHEREAS, After nearly 5 years working at EBHO, Gloria Bruce was selected as their Executive Director, a position which she seamlessly accepted; and

WHEREAS; In the almost 8 years of her executive leadership, she successfully expanded EBHO's demand for affordable housing prioritization and developments to the unchartered expanse of Contra Costa County; and

WHEREAS, Gloria's exceptional leadership qualities are highlighted by her ability to bring developers, labor, and community advocates into mutually beneficial alignment with EBHO's affordable housing mission; and

WHEREAS, She expanded EBHO's passion for affordable housing to include the needs of the City's renters, both private and subsidized, as well as Oakland's homeless residents; and

WHEREAS, Gloria was a key leader in campaigns for local housing bonds, including Alameda County's Measure A1 (\$580 million), Berkeley Measure O (\$130m), Oakland Measure KK (\$100m), Oakland Measure U (\$350m); and

WHEREAS, She was a key leader in negotiations with Alameda Building Trades Council for strong labor standards in County bond-financed housing; and

WHEREAS, Gloria championed the three P's approach to addressing the housing crisis: Protection, Preservation, and Production; and

WHEREAS, She championed passage of Oakland's Affordable Housing Impact Fee; and

WHEREAS, Gloria served on Oakland Mayor Libby Schaaf's Housing Cabinet and led coalition efforts for a strong public lands policy; and

WHEREAS, Gloria has served on boards and advisory boards for other organizations, including EveryOne Home, California Reinvestment Coalition, and the Alameda County Housing & Community Development Advisory Commission; and

WHEREAS, Most anyone who has had the opportunity to witness Gloria Bruce speak was moved to action; and

WHEREAS, Her passion, intellect and bravery has always shone through and provided the map for our community to follow.

WHEREAS, Gloria excels as a convener, with an unparalleled ability to bring together elected officials, advocates, industry partners and most importantly, those with lived experience, to find our common ground and pursue our common good; now, therefore, be it

RESOLVED: That the City of Oakland and the Oakland City Council greatly appreciate and express their gratitude for Gloria Bruce's incredible work and commitment to the affordable housing in our City; and be it
