RESOLVED: That Resolution No. 89376 C.M.S. is amended to replace "Unity Council" as it appears at the top of Page 3 of Resolution No. 89376 C.M.S. with "Spanish Speaking Unity Council of Alameda County, Inc., California Corporation No. **CO527967**" as indicated below, with additional amended text in <u>underline</u> typeface:
