RESOLUTION NO. 89601 C.M.S.

INTRODUCED BY COUNCIL PRESIDENT NIKKI FORTUNATO BAS

RESOLUTION AMENDING RESOLUTION NO. 89376 C.M.S., WHICH AMONG OTHER THINGS GRANTED ONE HUNDRED TEN THOUSAND FIVE HUNDRED DOLLARS (\$110,500) TO THE UNITY COUNCIL AS FISCAL SPONSOR FOR THE OAKLAND VIETNAMESE CHAMBER OF COMMERCE, IN ORDER TO CORRECT THE NAME OF UNITY COUNCIL TO THE SPANISH SPEAKING UNITY COUNCIL OF ALAMEDA COUNTY, INC.

WHEREAS, on July 26, 2022, the Oakland City Council adopted Resolution No. 89376 C.M.S., which awarded grants to community services providers; and

WHEREAS, Resolution No. 89376 C.M.S. awarded a grant of One Hundred Ten Thousand Five Hundred Dollars (\$110,500) to the "Unity Council" as fiscal sponsor for the Oakland Vietnamese Chamber of Commerce for Little Saigon business support and safety resources; and

WHEREAS, Resolution No. 89376 C.M.S. does not accurately describe the full legal entity name of "Unity Council"; and

WHEREAS, "Spanish Speaking Unity Council of Alameda County Inc." is the full legal name for "Unity Council", California Corporation No. **CO527967**; now, therefore, be it

RESOLVED: That Resolution No. 89376 C.M.S. is amended to replace "Unity Council" as it appears at the top of Page 3 of Resolution No. 89376 C.M.S. with "Spanish Speaking Unity Council of Alameda County, Inc., California Corporation No. **CO527967**" as indicated below, with additional amended text in underline typeface:


