The Sr. Contract Compliance Officer conducted a compliance analysis of six (6) bids submitted to the City in response to the above referenced project. Below are the results of the compliance evaluations for the most recent L/SLBE Program for, (a) the minimum 50% Local and Small Local Business Enterprise (L/SLBE) participation requirement; and (b) a preliminary review for compliance with the Equal Benefits Ordinance (EBO.

**Comments:** As noted above, Bay Construction achieved 59.55% SLBE participation. However, they failed to meet 50% trucking requirement. Marinship Development Interest failed to the minimum 50% L/SLBE and 50% trucking requirement. Therefore, both firms are non-responsive to L/SLBE program.
