**RESOLUTION APPOINTING COUNCILMEMBER KEVIN JENKINS TO  
REPLACE COUNCILMEMBER LOREN TAYLOR ON THE ALAMEDA-  
CONTRA COSTA TRANSIT DISTRICT (AC TRANSIT) INTER-AGENCY  
LIAISON COMMITTEE**

**WHEREAS**, the City of Oakland is a member of The Alameda-Contra Costa County Transit District (AC Transit) Interagency Liaison Committee (ILC) with the purpose of improving transportation service planning coordination between Oakland and AC Transit; and

**WHEREAS**, transit issues subject to these collaborative discussions include and are not limited to: new residential and commercial developments, roadway and right-of-way changes and projects, service planning including: routes, schedules and bus stops, service partnerships, transit corridor projects such as Rapid Bus and Bus Rapid Transit, area service plan proposals such as AC Go or Transbay Tomorrow and connections between multiple transit modes; and

**WHEREAS**, ILCs are Brown Act committees established by the AC Transit Board of Directors and a local jurisdiction; and

**WHEREAS**, the ILC is composed of three AC Transit Board Members and three partner agency city councilmembers; and

**WHEREAS**, decisions of the ILCs are non-binding on the District or partner agency, and the ILC does not have the authority to enter into agreements, contracts or other binding decisions on behalf of either organization; and

**WHEREAS**, the City Council's Rules of Procedures (Resolution No. 89588 C.M.S.) provide that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council;" now, therefore, be it

**RESOLVED:** That the City Council appoints Councilmember Kevin Jenkins To Replace Councilmember Loren Taylor to the ILC to participate and carry out the work and responsibilities of this committee.


