#### **RECOMMENDATION**

Staff Recommends That The City Council Receive an Informational Report from the Finance Department on a Budget Outlook Message & Calendar Providing an Overview of The FY 2023-25 Budget Development Process and Estimated Key Dates of Budget Events.

#### **EXECUTIVE SUMMARY**

Staff is required to bring a Budget Outlook Message and Calendar report to the City Council pursuant to the Consolidated Fiscal Policy (<u>Ordinance No. 13487 C.M.S.</u>). This report is intended to provide a list of all dates for key budget events including the release of the Mayor's Proposed Budget, Community Budget Forums, and City Council meetings.

#### **BACKGROUND / LEGISLATIVE HISTORY**

The Consolidated Fiscal Policy (CFP) requires the production of a Budget Outlook Message and Calendar report. The CFP was most recently updated by <u>Ordinance No. 13487 C.M.S.</u> on April 13, 2018.

#### **ANALYSIS AND POLICY ALTERNATIVES**

#### Budget Outlook Message

During the FY 2023-25 Biennial Budget Development Cycle the City will be charged with resolving the largest projected General Purpose Fund (GPF) shortfall in its history. The FY 2023-25 baseline budget in January showed a \$345 million shortfall (\$175 million in Year 1 and \$170 million in Year 2) in the GPF and significant shortfalls in many other funds. The deficit amounts have been refined over the past few months with updated revenue projections and

expenditure projections (\$172 million in Year 1 and \$145 million in Year 2). As noted in December 2022 Informational Memorandum titled "Revenue and Expenditure Report FY 2021-22 Q4 and FY 2022-23 Q1" and the "FY 2022-23 Second Quarter Revenue And Expenditure Report" presented this Committee on March 14, 2023, the shortfall reflects increased expenditures from approved wage increases and other rising costs, such as pensions and insurance premiums.

In order to balance the GPF and other funds, Departments have been provided with a balancing measure target by fund for each year of the biennial budget. These balancing targets (dollar amount) by Department are addressed below.

Department Directors were instructed to employ balancing measures such as increases in service charges, fees, and other revenues to the extent allowable by law, and reductions in ongoing expenditures. Proposed increases to fees must be included in the Department's Master Fee Schedule submission and are subject to Council approval. Revenue proposals may not be speculative and will be vetted with the Finance Department and City Attorney's Office.

Departments were asked to propose their lowest priority services for reduction or elimination. Budget proposals should mitigate the impacts to service levels as much as possible, particularly if such a service reduction (or elimination) would impact communities experiencing historical racial disparities or have high-need and/or vulnerable populations.

The Department Director's under the direction of the City Administrator and Mayor's Office have been diligently working towards closing the gap and providing responsive and responsible solutions in concert with the Mayor's Priorities, address the City Council's Priorities and are responsive to the community's needs.
