COST \$125,000 TO RE TRAIN 5 PIOLTS

➢ WILL NEED TO RE TRAIN HELICOPTER PILOTS TO FLY AIRPLANES

> TRAINING COST FUNDED BY THE AIRPLANE LOAN

IT IS SIGNIFICANTELY CHEAPER AND LESS TIME CONSUMING TO RETRAIN A HELICOPTER PILOT TO FLY AN AIRPLANE THAN IT IS TO TRAIN A ZERO TIME PILOT

> TRAINING TAKES 6 MONTHS AND WILL BE COMPLETE BEFORE AIRPLANE IS DELIVERED

Airplane Cost:

\$2,539,499 \$1,733,761 \$125,000

Mission Equipment cost (radio, camera, mapping systems computers) Training (5 pilots)

\$4,398,260 Total (\$4.4 million)

Airplane price fluctuates daily with changes in the Euro and interest rate changes.

Price will be locked in upon loan completion or deposit.

Airplane Loan:

- \succ Paid for by the general fund.
- 15 year loan 4.45% Interest rate @\$423,210.29 a year
- > 10 year loan 4.25% interest rate \$569,318.97 a year



- Save \$7 million dollars over the 30 year life of the airplane
- 21,000 gallon's of jet fuel not used per year
- Avoiding 187 metric tons of CO2 emissions annually
- Equivalent to 40 passenger vehicles not driven for an entire year
- Significant reduction in helicopter noise.

Airplane & Helicopter maintenance:

- Paid out of grant funds
- > Once Airplane is in service full time estimated (4th quarter 2024)
- \$425,000 annual budget for Airplane & Helicopter maintenance
 \$300,000 for Airplane
 \$125,000 for Helicopter
 - > \$125,000 for Helicopter
- Helicopter shall only be used under one of the following 3 circumstances
 - 1. Training
 - 2. While the Airplane is in maintenance
 - 3. Weather prevents the Airplane from flying

TIMELINE

- > 1 YEAR AFTER CITY COUNCIL APPROVES THE PURCHASE OF THE AIRPLANE AND FIRST PAYMENT MADE.
- ► FIRST PAYMENT CAN BE DEPOSIT OR COMPLETION OF FINANCING CONTRACT.
- AFTER AIRPLANE IS DELIVERED IT WILL REQUIRE "COMPLETION" COMPLETION IS INSTALLATION OF LAW ENFORCMENT MISSION EQUIPMENT:
 - > POLICE RADIOS, CAMERAS, COMPUTERS, AND MAPPING SYSTEMS
