INTRODUCED BY COUNCILMEMBER DAN KALB

RESOLUTION IN SUPPORT OF AB 1267 (TING), THE ELECTRIC VEHICLE INITIATIVE FOR GASOLINE SUPERUSERS, REQUIRING THE CALIFORNIA AIR RESOURCES BOARD (CARB) TO CREATE AN ADDITIONAL ZERO EMISSIONS VEHICLE (ZEV) INCENTIVE AWARD FOR GASOLINE SUPER USERS AND REQURE CARB TO REPORT ON THE AMOUNT OF GREENHOUSE GAS EMISSIONS REDUCED PER DOLLAR SPENT ON ZEV INCENTIVES

WHEREAS, the City of Oakland has been on the forefront of climate policy for decades; and

WHEREAS, transportation is the largest source of GHG emissions in California, accounting for 38% of all statewide emissions¹; and

WHEREAS, burning gasoline in passenger vehicles is the single biggest source of California's CO2 emissions, at 25.5%²; and

WHEREAS, the California Air Resources Board (CARB) Board Scoping Plan calls for a 50% reduction in gasoline use between 2021 and 2030 to meet statutorily mandated GHG reduction requirements; and

WHEREAS, the California Air Resources Board (CARB) Board Scoping Plan calls for a 50% reduction in gasoline use between 2021 and 2030 to meet statutorily mandated GHG reduction requirements; and

WHEREAS, Gavin Newsom issued executive order N-79-20., which requires all new cars purchased after 2035 to be Zero Emission Vehicles (ZEV); and

WHEREAS, AB 1267 would require CARB to create an additional ZEV incentive for gasoline superusers; and
