Mission Statement

The Mission of the City of Oakland Planning and Building Department is to improve Oakland's physical, social, and economic environments through sustainable development that embraces three core principles: health, opportunity, and equity.



Goals

- Improve experience of Oakland residents to live and work in the city through the strategic development of housing, commercial, and cultural facilities
- Promote sustainable development and environmental justice
- Improve and enact code enforcement to keep Oakland residential and business neighborhoods safe and healthy
- Enhance existing revenue streams through supporting development that meets the needs of our communities
- *Provide responsive, timely, and effective customer service*



Principal Services

- PBD performs the intake, review, permitting, and inspection of construction projects; and the code enforcement on existing structures in compliance with the Oakland Municipal Code and General Plan.
- These services are accomplished through the following units within PBD:
 - Permit Counter review, intake, and routing proposals
 - Planning review for Planning Code and Subdivision Ordinance approval
 - Building building plan check of permits and inspection of projects for Building Code Compliance and property maintenance through Code Enforcement

Current Project Prioritization

- Current Project Prioritization *
 - 1. 100% affordable housing
 - 2. Affordable component (<100%)
 - 3. Supportive housing/homeless support
 - 4. Market rate housing
 - 5. Non-Residential Development

*Emergency projects re: life safety have highest priority



Overview of Funding Sources

• PBD receives 99.6% of its funding from Fund 2415 (Development Services Fund) as authorized under City Ordinance No. 12741 C.M.S.

 Fund 2415 was created in 2006 to "<u>create a direct correlation between revenues</u> realized from fees and penalties which are collected for development and enforcement services paid by citizens of the City and the associated expenditures related to these activities and made necessary by providing <u>services</u>." (Ordinance No, 12741 C.M.S.)



Overview of Funding Sources

- Fund 2415 receives all <u>"fees and penalties authorized by State Law and</u> <u>City ordinance, including all fees and penalties identified under the</u> <u>'Community and Economic Development' Section in the...Master Fee</u> <u>Schedule.</u>" (Ordinance No, 12741 C.M.S.)
- The Ordinance <u>"restricts expenditures from the Development Services</u> <u>Fund to paying direct and indirect costs of the services and programs</u> <u>supported by the revenue received by the Fund.</u>" (City Attorney Opinion 6/18/19)

Budget Proposals & Service Impact

- Add 1.0 FTE Business Analyst III: Will allow for more expedient implementation of enhancements to the digital platform Accela.
- Add 1.0 FTE Public Services Representative and 1.0 FTE Sr. Public Services Representative: The Public Services Representatives will be interacting with the public face-to-face around issues of code enforcement, permitting and code inspections.
- Add 1.0 FTE Planner III: The position will bolster the Department's ability to provide service in the areas of historical preservation, land use, zoning, urban design, and environmental impact.
