INTRODUCED BY COUNCILMEMBER KALB AND COUNCILMEMBER REID

ADOPT A RESOLUTION IN SUPPORT OF SB 98 (PORTANTINO) WHICH WOULD CHANGE THE DEFINITION OF "AVERAGE DAILY MEMBERSHIP" IN ORDER TO PROVIDE ADDITIONAL EDUCATION FUNDING TO LOCAL EDUCATION AGENCIES OF WHICH THIRTY PERCENT SHALL BE USED FOR PURPOSES OF LOCAL EDUCATION AGENCY EXPENDITURES TO ADDRESS CHRONIC ABSENTEEISM AND HABITUAL TRUANCY BY PROVIDING SERVICES AND SUPPORTS THAT HAVE BEEN DETERMINED TO IMPROVE SCHOOL ATTENDANCE OR ADDRESS THE ROOT CAUSES OF ABSENTEEISM

WHEREAS, California is one of six states that does not consider enrollment figures for determining state aid to school districts; and

WHEREAS, California funds schools based on average daily attendance (ADA) instead, which is calculated as the total attendance divided by the number of school days in session; and

WHEREAS, Districts plan their budgets and operations based on enrollment but receive funds based on attendance; and

WHEREAS, this bill defines "average daily membership" as the quotient of the aggregate enrollment days for all pupils in a school district or county office of education, from transitional kindergarten to grade 12, divided by the total number of instructional days for the local educational agency (LEA) in an academic year; and

WHEREAS, LEA includes school districts, county office of educations and charter schools; and

WHEREAS, this bill would require LEAs to direct at least 30% of their additional education funding to existing LEA expenditures to address chronic absenteeism and habitual truancy; and

WHEREAS, this bill is sponsored by the California School Employees Association, the Los Angeles Unified School District, and the State Superintendent of Public Instruction Tony Thurmond; now, therefore, be it

RESOLVED: That the City Council directs the City Administrator or his designee to immediately distribute this Resolution upon its adoption to Governor Gavin Newsom and State Senator Portantino.
