RESOLUTION NO. 89786 C.M.S.

RESOLUTION AMENDING RESOLUTION NO. 89376 C.M.S., WHICH AWARDED TWO GRANTS TO OAKLAND HOUSING SECURE IN THE TOTAL AMOUNT OF ONE MILLION DOLLARS (\$1,000,000) FOR LEGAL SERVICES AND HOUSING ASSISTANCE, TO CORRECT THE NAME OF GRANT RECIPIENT FROM OAKLAND HOUSING SECURE TO CENTRO LEGAL DE LA RAZA, INC.

WHEREAS, on July 26, 2022, the City Council adopted Resolution No. 89376 C.M.S., which awarded grant agreements to community service providers for Fiscal Year 2022-2023; and

WHEREAS, Resolution No. 89376 C.M.S. awarded two grants to Oakland Housing Secure in the amount of seven hundred fifty thousand dollars (\$750,000) for legal services and in the amount of two hundred and fifty thousand dollars (\$250,000) for rental assistance; and

WHEREAS, Oakland Housing Secure is a collaborative of community organizations with deep roots in Oakland, partnering to prevent displacement and homelessness, which has developed a coordinated strategy using an array of tools including community outreach and education, legal representation, financial assistance, and social services to help the most vulnerable community members attain housing security; and

WHEREAS, Centro Legal de la Raza, Inc. ("Centro Legal") is the current administrator of Oakland Housing Secure and will subgrant a portion of these funds to other community organizations within the collaborative; and

WHEREAS, Resolution No. 89376 C.M.S. does not accurately describe the legal recipient of the intended grant funding and needs to be amended accordingly; and

WHEREAS, the City Council wishes to issue these grants to improve the lives of Oakland community members; now, therefore, be it

**RESOLVED:** That Resolution No. 89376 C.M.S. is amended to correct the name of "Oakland Housing Secure" to "Centro Legal de la Raza, Inc.," as listed below in **Table 1** with additional amended text in <u>double underline</u> typeface, and removed amended text in <u>strikethrough</u> typeface:
