RESOLUTION NO. 89846 C.M.S.

RESOLUTION AMENDING RESOLUTION NO. 85717 (2015) AND RESOLUTION NO. 88677 C.M.S. (2021) TO AUTHORIZE THE CITY ADMINISTRATOR TO EXERCISE A ONE-YEAR OPTION TO EXTEND THE TERMS OF PROFESSIONAL SERVICE AGREEMENTS FOR ON-CALL ECONOMIC CONSULTING SERVICES AND TO INCREASE THE AMOUNT OF EACH AGREEMENT BY AN AMOUNT NOT TO EXCEED TWO HUNDRED THOUSAND DOLLARS (\$200,000) WITH THE FOLLOWING FOUR FIRMS: (1) CENTURY URBAN, LLC, (2) ECONOMIC & PLANNING SYSTEMS, (3) HAUSRATH ECONOMICS GROUP, AND (4) KEYSER MARSTON ASSOCIATES.

WHEREAS, the Economic and Workforce. Development Department ("EWD") conducts economic, financial and real estate analyses for properties that the City of Oakland ("City") and Oakland Redevelopment Successor Agency ("ORSA") own, plan to acquire, assist with the development of or dispose of; and

WHEREAS, EWD desires to continue to have outside consulting services available on an as-needed basis to assist with select City projects that involve expertise in economic, financial and real estate matters; and

WHEREAS, pursuant to Resolution No. 85717 C.M.S. adopted on July 21, 2015, the City Council authorized Professional Service Agreements ("PSAs") for on-call economic consulting services for three-year terms with three additional one-year options to extend, and for an amount not to exceed Five Hundred Thousand Dollars (\$500,000) for the following seven firms: (1) Aecom, (2) Century Urban, LLC, (3) David Paul Rosen & Associates, (4) Economic & Planning Systems, (5) Hausrath Economics Group, (6) Keyser Marston Associates, and (7) Willdan Financial Services; and

WHEREAS, pursuant to Resolution No. 88677 C.M.S. adopted on June 1, 2021, the City Council authorized the City Administrator to amend Resolution No. 85717 C.M.S. to extend the terms of the PSAs by an additional two years with a 1-year option to extend, to be exercised upon the approval of City Council; increase the amount of each agreement by Five Hundred Thousand Dollars (\$500,000); and waive the request for proposal process for the following five firms to provide on-call economic consultant services: (1) Century Urban, LLC., (2) David Paul Rosen & Associates, (3) Economic & Planning Systems, (4) Hausrath Economics Group, and (5) Keyser Marston Associates; and

WHEREAS, EWD staff anticipates that several projects currently underway will continue to utilize those on-call economic consultant services; and

WHEREAS, on-call economic consulting services will continue to be funded through the various individual projects and funds will be identified prior to the performance of the on-call services; and

WHEREAS, the on-call economic consultants have performed their work with a high level of professionalism and excellence, and the City finds that is in the best interest of the City to continue to utilize the assistance of the on-call economic consultants for an additional one year term, and to increase the amount of each agreement by an amount not to exceed Two Hundred Thousand Dollars (\$200,000) with (1) Century Urban, LLC., (2) Economic & Planning Systems, (3) Hausrath Economics Group, and (4) Keyser Marston Associates, (collectively, the "Consultants"); and

WHEREAS, through the City's Request for Qualifications process in 2015, the Consultants met the requirements for on-call economic consulting services; and

WHEREAS, the Consultants have previously met the City's 50% Local/Small Local Business Enterprises (LBE/SLBE) Program requirements; and

WHEREAS, the Consultants have previously been determined to be in compliance with the Equal Benefits Ordinance (EBO) and will continue to be compliant during the extended 1-year term; now, therefore, be it

RESOLVED: That the City Council authorizes the City Administrator to amend Resolution No. 85717 C.M.S (2015) and Resolution No. 88677 C.M.S. (2021) and extend the current Professional Services Agreement (PSA) for one additional year with the following four firms for the provision of on-call economic consultant services: (1) Century Urban, LLC., (2) Economic & Planning Systems, (3) Hausrath Economics Group, and (4) Keyser Marston Associates; and be it

FURTHER RESOLVED: That the total extended amount of the PSA for each of the Consultants shall be for an additional not-to-exceed amount of Two Hundred Thousand Dollars (\$200,000); and be it

FURTHER RESOLVED: That such amendments to the PSAs for Consultants shall be approved for form and legality by the Office of the City Attorney, and a copy shall be kept on file with the City Clerk.
