**RESOLUTION AFFIRMING OAKLAND'S COMMITMENT TO QUEER  
AND TRANS LIBERATION; RECOGNIZING, CELEBRATING, AND  
HONORING OAKLAND LGBTQ PRIDE EVENTS AND OUTSTANDING  
LGBTQ OAKLANDERS AND ORGANIZATIONS; AND DECLARING  
SEPTEMBER 2023 "OAKLAND LGBTQ PRIDE MONTH"**

**WHEREAS**, on September 10th, 2023, Oakland Pride celebrated, uplifted, and honored the Lesbian, Gay, Bisexual, Transgender, and Queer (LGBTQ) communities of Oakland and the surrounding Bay Area; and

**WHEREAS**, the Oakland metropolitan area has the highest percentage of LGBTQ residents of any in the entire United States<sup>1</sup>; and

**WHEREAS**, the City of Oakland has been at the forefront of fighting for justice and equity for the LGBTQ community; and

**WHEREAS**, Oakland celebrates its diverse LGBTQ community and specifically acknowledges the pivotal role of Black, Brown, Indigenous, and Disabled queer and trans leadership in our fight for LGBTQ liberation and justice; and

**WHEREAS**, in October of 2009, Oakland Pride was incorporated for LGBTQ and allied communities to celebrate pride in their community and the beautiful City of Oakland; and

**WHEREAS**, Pridefest Oakland was created and brought together thousands of queer Bay Area residents to celebrate LGBTQ pride in 2021; and

**WHEREAS**, on September 9-10, 2023, Oakland Pride and Pridefest Oakland united for Oakland Pride 2023 which was a display of mutual support for each other, the LGBTQ community, and Oakland at-large so that every marginalized voice can be heard; and

**WHEREAS**, Mayor Sheng Thao hereby honors and recognizes **Johanna Holden**, an East Oakland resident, Organizing Director for the Oakland LGBTQ Center, and proud Jew, lesbian, and transgender woman who works every day to develop programming and solutions to support Oakland's LGBTQ+ community while continuing to give back to her community as she co-facilitates the center's White Allyship and Accountability Group and the Trans Women and Trans Femmes' Support Circle; and

**WHEREAS**, Vice Mayor Rebecca Kaplan hereby honors and recognizes the **Transgender Law Center**. The Transgender Law Center (TLC) changes law, policy, and attitudes so that all people can live safely, authentically, and free from discrimination regardless of their gender identity or expression. TLC, which was originally founded in Oakland, is the largest national trans-led organization advocating for a world in which all people are free to define themselves and their futures. Grounded in legal expertise and committed to racial justice, TLC employs a variety of community-driven strategies to keep transgender and gender nonconforming people alive, thriving, and fighting for liberation; and

**WHEREAS**, Council President Nikki Fortunato Bas hereby honors and recognizes **Penny Baldado**. Penny was born and raised in the small town of Davao City, Philippines. They migrated to the Bay Area and have lived here for 20 years. They are the proud owner and operator of Cafe Gabriela, a community hub and foodie destination located in Downtown Oakland in District 2, which opened in 2010. The cafe actively supports our community and is named after the honorable Gabriela Silang, a Filipina revolutionary who led a revolt against Spanish colonizers on the archipelago. Passionate about food and social justice, they created this intentional space that can embrace all of their experiences as a trans queer person of color, a formerly undocumented immigrant, and as a person of working class background, as well as provide a safe, welcoming space for their workers, customers and friends. They made a 7 minute autobiographical documentary *My Beautiful Resistance* narrating all these identities. District 2 is grateful for Penny's vision, work and love for Oakland; and

**WHEREAS**, Council President Pro Tempore Dan Kalb hereby honors and recognizes **Sarah Crowell**. Sarah has been an outstanding asset to our community through her work at Destiny Arts Center. Sarah believes that the arts are an essential component of the journey to social justice. For the last 30 years Sarah has held many leadership roles at Destiny Arts Center such as Executive Director, Artistic Director, and Co-Founder of the Destiny Arts Youth Performance Company. Founded in 1988 Destiny Arts uses movement-based arts to uplift youth voice, supporting pathways for young people to express themselves, advocate for justice and equity, fight against the systemic racism that continues to impact BIPOC youth, and build a community where everyone feels seen, valued, and free. Her group, The Destiny Arts Youth Performance Company, won the National Arts and Humanities Youth Program Award in 2017 and has been the subject of 2 documentary films. Sarah has received numerous other accolades, and most importantly, continues to inspire children in our community to express themselves freely, advocate for social change, and create a just and equitable society; and

**WHEREAS**, Councilmember Carroll Fife hereby honors and recognizes **Jessie Spivey** of West Oakland. As Director of Elder Services for the Oakland LGTBQ Community Center, Jessie promotes a positive and healthy quality of life for elder LGBTQ+ individuals 55+ by ensuring they continue to be supported, respected, and connected as they advance in age. Jessie serves as Operations Manager at The Oakland LGBTQ Center and Co-Facilitator of Black Connect, a support group for Queer Black cis and trans masculine men. He is also the creator and founder of

The Doudad, a full circle birth Doula practice that amplifies the voices of men in birthwork. District 3 is truly grateful for the years of service and dedication Jessie Spivey and the Oakland LGTBQ Center has given to our community; and

**WHEREAS**, Councilmember Janani Ramachandran hereby honors and recognizes DJ **Lady Ryan** for her trailblazing leadership in the LGBTQ music and arts community. A beloved professional DJ, vocalist, and spiritual conductor, Lady Ryan is a pivotal fixture and cultural icon in the LGBTQ arts and social scene, organizing gatherings that focus on creating safe spaces especially for BIPOC queer women, transgender, and nonbinary communities. Whether enchanting crowds at Warriors' games, gracing the airwaves on 91.7 KALW, or curating nationally recognized events that puts Oakland in the spotlight for all the right reasons — including Soulouvely and Sweet Spot — Lady Ryan infuses her vast knowledge of musical diversity evokes feelings of safety, joy, and belonging; and

**WHEREAS**, Councilmember Noel Gallo hereby honors and recognizes **Richard Fuentes**. A public service professional with over 15 years of experience with deep and broad relationships throughout local and state government agencies, elected officials, businesses, foundations and non-profits. As an LGBTQ Latino, Richard is passionate about finding equitable solutions to the Bay Area's most challenging issues. Fuentes has promoted equality within BART, serving on the agency's first panel convened to discuss LGBTQ issues in the workplace. He is often called upon for public meetings where his Spanish-language skills are a tremendous asset, giving residents the comfort of speaking in their native tongue. He's involved in the community in other ways as well. He serves on the board of directors at Frameline, whose mission is to change the world through the power of cinema. He helps Frameline expose artists with unique voices to audiences through film festivals, youth programs and workshops. Fuentes has served as president of the Hoover School Site Council, spearheading efforts that transformed it into the most improved elementary school in West Oakland. As an elected city of Oakland Community Development Block Grant Board member, he championed funding for community programs and helped direct \$1.1 million in funding for youth to access healthcare and job-training programs. Fuentes also co-founded the De La Fuente Scholarship Foundation, Oakland's only Latino Scholarship Foundation, which provides 25 annual scholarships to Oakland students pursuing higher education. Fuente's work does not stop at BART. Fuentes is co-owner of The Port, an LGBTQ-themed bar and entertainment space in Uptown Oakland. Its permanent art collection features portraits of six legendary LGBTQ social justice leaders, created by six Bay Area artists of color; and

**WHEREAS**, Councilmember Kevin Jenkins hereby honors and recognizes **Rowena Brown**. Rowena Brown is an East Bay native and a fierce advocate for community in Oakland. A proud product of public schools, the Peralta Colleges and Mills College, Rowena has lived, worked, and played in Oakland for over a decade. Rowena currently serves as the District Director for Assemblymember Mia Bonta and recently graduated from the University of California Law, San Francisco. As a Black and Queer woman, who lost both of her parents by the age of 17, Rowena knows firsthand why representation is key to transforming our communities. Rowena has served the community in Oakland for more than a decade. From teaching civic education to young people in Oakland to providing free eye exams and glasses to K-12 students, Rowena has worked to ensure students have the tools they need to succeed. During the worst months of the pandemic, Rowena connected vulnerable families to COVID-19 resources, including testing and vaccination sites, renter's rights and benefits, and healthy food for communities at major risk from the virus. That passion for helping the community has carried over into her current job in the CA State Assembly, bringing together communities, labor unions, neighborhood groups, and small

businesses to ensure that they have effective representation in Sacramento. As a quintessential organizer, Rowena has dedicated herself to bringing Oakland communities into power and dignity, fighting for equitable access to services that all deserve; and

**WHEREAS**, Councilmember Treva Reid hereby honors and recognizes **Christopher Mina**. Mr. Mina is a renowned curler in the sporting world, having represented the United States at the highest levels of curling on the global stage. In 2020, Mina represented the US in the Winter World Masters Games held in Austria. In January 2024, Mina will again represent the United States in the World Masters Games. Mina is a founding member of world-renowned San Francisco Bay Area Curling Club (SFBACC). In 2022, SFBACC, after years of training at the Oakland Ice Center, found a permanent home in the Hegenberger corridor of District 7. SFBACC is the oldest club in California and the very first dedicated curling facility in our region. Mr. Mina was nominated for the role of Director-at-Large at SFBACC, a role he coveted as a member of the LGBTQIA+ and BIPOC community. Mina saw this appointment as a way to represent his community with pride. Nestled amongst legacy businesses of District 7, the SFBACC exemplifies the unique make-up of District-7 organizations, as ever-growing diverse business district, anchored by some of Oakland’s most storied companies, but welcoming to incubate the new ideas that contribute to the Bay Area’s reputation of innovation. Outside of supporting the operations at the SFBACC, Mina serves as a Grants Accountant for the Unity Council where he manages the agency’s state and federal grants for Head Start & Early Head Start Programs; and

**WHEREAS**, a record number of bills restricting the rights of LGBTQ people have been introduced across the country this year, with a particular focus on eroding protections for trans youth<sup>2</sup>; and

**WHEREAS**, these bills do immeasurable harm to LGBTQ communities even when they fail to become law, with 86% of transgender and nonbinary youth saying recent debates around anti-trans bills have negatively impacted their mental health<sup>3</sup>; and

**WHEREAS**, LGBTQ people who are more connected to the LGBTQ community are less likely to report suicidal behavior<sup>4</sup>; and

**WHEREAS**, Oakland Pride offers life-saving opportunities for visibility, connection, and belonging; and

**WHEREAS**, now as much as ever before, Oakland Pride provides a critical form of resilience, resistance, and defiance in the face of hatred and bigotry, and a vital opportunity to celebrate and uplift the diverse and beautiful LGBTQ communities of Oakland; now, therefore, be it
