Basis for Appeal - Attach meet

T23-094 Tree Permit Request is a Development Related Tree Removal Permit requesting to remove 2 Trees as part of a construction related project. The permit is required to be included in the applicant's application for Development and Design review, which had been previously submitted to the City Zoning.

• The appellant (myself) had challenged that application submission, stating the building site design violated the easement rights of my property.

The placement and location of the proposed site building plan accompanying the Development Related Tree Permit is not a workable plan, not meeting the measurement and setbacks of the easement rights and therefore cannot be addressed until the design issue challenge is addressed regarding coming up with a workable plan that protects the rights of all the property owners.

The arboricultural Inspector -

Came to the site conference with a conclusion already made, letting me know right away that he is going to approve the permit because he has looked at the Trees, and it does not matter whether a building is going to be located on the site or not. He stated a building may never be located on the site and he will still approve it.

He made his determination and approval based upon a Non-Development Related Tree Removal request. This is a development related request, and related to a design that is being challenged and currently with City Attorney.

The approval is therefore being appealed and needs to be set aside.

The concern that was brought up in the meeting was that there is a dispute about an easement and how the placement of the proposed new home will affect the adjacent property. Tree Services has no authority over easements and is not able to consider an easement in determining whether a tree should or should not be removed.
