

### RESOLUTION ACCEPTING AND OVERSEEING THE DISTRIBUTION OF \$55,000 IN DINING CREDITS PROVIDED BY DOORDASH

**WHEREAS**, DoorDash, an online food delivery company, has generously donated \$55,000 in dining credits to support Oakland's mission of addressing food insecurity within the community; and

**WHEREAS**, this initiative aligns with Oakland's commitment to ensuring that all residents have access to nutritious meals, addressing a critical need within our community; and

**WHEREAS**, marginalized populations, including Black and Latinx adults, adults with disabilities, and noncitizen adults, face disproportionately higher levels of food insecurity, which underscores the importance of supporting initiatives like this; and

**WHEREAS**, the donation of \$55,000 in dining credits will help address barriers to accessing nutritious food, including limited distribution hours, transportation challenges, and health conditions that limit mobility; and

**WHEREAS**, this initiative is aligned with Oakland's commitment to ensuring equitable access to healthy meals and prioritizing the well-being of residents; and

**WHEREAS**, by partnering with nonprofit and community-based organizations with a well-established history in the field of food distribution, the City can efficiently distribute the dining credits to those in need; and

**WHEREAS**, partnering with nonprofits and community-based organizations promotes economic resilience, contributes to economic growth, and indirectly reduces the environmental impact of unhealthy food consumption by decreasing waste and plastic usage; and

**WHEREAS**, this distribution strategy aims to ensure equity by reaching underserved communities; now, therefore, be it

**RESOLVED**, that the City Administrator is hereby authorized to accept, appropriate and oversee the distribution of \$55,000 in dining credits provided by DoorDash to combat food insecurity within Oakland; and be it

**FURTHER RESOLVED:** that City Administrator shall ensure regular evaluations of the distribution process and require partner organizations to provide reports on the number of credits used, the number of individuals served, and the types of services provided.


