## **RE: A REPORT CALCULATING THE OAKLAND CITY MAYOR'S SALARY IN CONFORMITY WITH THE OAKLAND CITY CHARTER**

Dear President Reid and Members of the City Council:

## PURPOSE AND SCOPE

The Oakland City Charter, Article III, Section 300, states that the Council shall set the salary for the Mayor as follows:

"The salary shall be set by the Council, which shall be not less than 70% nor more than 90% of the average salaries of City Managers'/Chief Executive Officers of California cities within the three immediate higher and the three immediate lower cities in population to Oakland. The Mayor's salary shall be reviewed by the City Council in odd-numbered years and may be adjusted by the Council as provided for herein."

## SALARY SURVEY

The City Managers' Salary in the six cities was obtained by contacting the personnel department or City Manager's Office of each city. We were able to retrieve actual City Manager salaries from each City.
