Item S-6 Lobbyist Registration Ordinance

It seems that all interested parties agree that Oakland's current definition of an in-house lobbyist is overly broad. As a committed advocate for transparent government, as well as advocacy, I feel strongly that Oakland needs to maintain a law that continues to shine light on who is spending money to influence policy and how.

While our Lobbyist reporting requirements must remain strong, it needs appropriate safeguards so it does NOT:

- Chill advocacy
- Financially burden non-profits
- Cause advocates, who should not be classified as lobbyists, to be subjected to harassing or unjustified claims or fines.

Most other major California cities require in-house lobbyists to register. A brief summary of the standards they use to define an in-house lobbyist follows:

Orange County: any contact (501c3 and 501c6 exempt)

San Diego: any contact

San Diego County: any contact San Francisco: any contact

Irvine: any contact

Sacramento: 100 hours in a 3 month period Long Beach: 50 hours in a 3 month period Los Angeles: 30 hours in a 3 month period

Santa Clara County: 10 hours in a three month period

San Jose: 10 hours in a twelve month period Richmond: 10 contacts within two months

Los Angeles County: 5 contacts within three months



I cunnot support the Brunner proposal because it would effectively eliminate Oakland's inhouse lobbyist registration and reporting requirement. In my twelve years of working for City of Oakland officials, I can think of no one who would meet the criteria of spending one-third of their time lobbying Oakland officials. Brunner's proposal not only creates an overly-broad definition of in-house lobbyist that no known person would meet, it also would double the threshold for defining a contract lobbyist from \$1,000 in compensation per month to \$2,000.

California is the world's eighth largest economy and is represented by one-hundred-and-thirty-four (134) elected officials. Oakland is represented by eleven (11) elected officials. California's standard doesn't make sense for Oakland, as is evidenced by the fact that no City uses California's standard. I cannot support an amendment to Oakland law that would weaken the public's ability to see the potential influence of money on Oakland officials' decision-making.

PROPOSED MOTION:

Direct staff to return to the Rules Committee with proposed amendments to Oakland's Lobbyist Registration Ordinance as follows:

1. More clearly defines lobbying as direct communication to officials, where the communicator is being compensated, with the purpose of influencing governmental decisions, outside of the public eye.

2. More clearly defines what is NOT Lobbying, including:

- Speaking in public or sending written communication that also are part of the public record.
- Time spent attending a large group meeting with officials, while your position is not being expressed
- Advocating in your uncompensated role, e.g., as a neighborhood resident, volunteer, board member, etc.
- Time preparing for meetings
- Making requests or inquiries for basic city services, e.g., reporting graffiti or potholes.


3. More clearly defines who needs to register as an "In-House Lobbyist", including:

- Job title or job description that calls out lobbying local officials as a significant duty, or
- At least 40 hours making direct, private, compensated communications during a 3 month period.
- 4. Requires a complainant accusing an Individual of failing to register as an in-itouse lobbyist to produce sufficient evidence supporting a prima facie case as a condition to bringing a claim to the Public Ethics Commission.
- 5. Exempt non-profits 501(c)(1-28) from paying the registration fee.
- 6. Not require In-house lobbvists to register or report until all reporting and fee paying may be done entirely on-line.


