RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CASE OF BANKERS STANDARD INSURANCE COMPANY AS SUBROGEE OF CYNTHIA WOOD V. CITY OF OAKLAND AND DOES 1 THROUGH 25, INCLUSIVE, ALAMEDA COUNTY SUPERIOR COURT CASE NO. 22CV019905, IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$150,000.00) (DEPARTMENT OF PUBLIC WORKS – INVERSE CONDEMNATION)

WHEREAS, on January 22, 2022, a large redwood tree on City property, whose roots had been cut by a City crew 17 months earlier, fell onto the property of Cynthia Wood ("Wood") at 77 Bowling Drive.; and

WHEREAS, Wood submitted an insurance claim to their homeowner's carrier, Bankers Standard Insurance Company ("BSIC"). BSIC paid Wood \$226,081.27 for covered losses and then filed a subrogation lawsuit against the City asserting that the City is liable for the loss because its employees improperly destabilized the tree; and

**WHEREAS**, the tree caused significant damage to an automatic iron gate, a stucco fence, a patio and pergola, and external portions of the house. It also knocked down another large tree on the property; and

WHEREAS, Plaintiffs filed suit entitled *Bankers Standard Insurance Company as subrogee of Cynthia Wood v. City of Oakland, et al.*, and DOES 1-25, Alameda County Superior Court Case No. 22CV019905 alleging negligence, inverse condemnation, trespass, nuisance, and dangerous condition of public property; and

**WHEREAS**, without admitting fault or wrongdoing, the City has determined to compromise Plaintiffs' claims for the sum of One Hundred Fifty Thousand Dollars and Zero Cents (\$150,000.00); now therefore be it

**RESOLVED**: That the City Attorney is authorized and directed to compromise and settle the case of *Bankers Standard Insurance Company as subrogee of Cynthia Wood v. City of* 

Oakland, et al., and DOES 1-25, Alameda County Superior Court Case No. 22CV019905, for the sum of One Hundred Fifty Thousand Dollars and Zero Cents (\$150,000.00); and be it

**FURTHER RESOLVED**: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement.
