President Fortunato Bas and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled lawsuit for the agreement of the Oakland Police Commission Selection Panel ("Selection Panel") to make certain revisions to its policies and procedures.

This action arises out of a challenge to James Chanin's ("Chanin") service on the Selection Panel and the process the Selection Panel used to choose Police Commissioners for the 2023 term. Plaintiffs contend that Chanin had a conflict that precluded Chanin's service on the Selection Panel because Chanin is one of plaintiffs' counsel in *Delphine Allen et al. v. City of Oakland*, United States District Court Case No. 00-cv-04599-WHO, an ongoing federal civil rights case alleging police misconduct. Plaintiffs also contended that the Selection Panel acted arbitrarily and capriciously in conducting its selection process for the 2023 term. Both a trial court and a court of appeal have preliminarily rejected Plaintiffs' claims and refused to intervene in the process of selecting Police Commissioners for the 2023 term.

The City has determined that a settlement to agree to make certain revisions to the Selection Panel's Policies and Procedures, without admitting liability and to avoid further litigation, in exchange for a dismissal with prejudice of the action and agreement that both sides will bear their own costs and attorneys' fees, is in the best interest of the City.

¹ The *Allen* Plaintiffs alleged misconduct by Oakland police officers known as the "Riders, including kidnapping, planting evidence, and beating the defendants and that the <u>Oakland Police Department</u> turned a blind eye to police misconduct. In 2003 the City and plaintiffs settled the litigation entering into a negotiated settlement agreement ("NSA") requiring reforms. The City continues to be under court oversight regarding the NSA.
