RESOLUTION NO. 83312 C.M.S.

RESOLUTION REVISING RESOLUTION NO. 82300, WHICH CONFIRMED THE MAYOR'S APPOINTMENT OF GREG HARTWIG TO THE OAKLAND HOUSING AUTHORITY BOARD OF COMMISSIONERS, TO REFLECT THE CORRECT TERM

WHEREAS, the City Council adopted Resolution No. 6341 C.M.S. pursuant to the California Health and Safety Code section 34270, which authorizes the City of Oakland to declare the need for a housing authority by adopting such a resolution; and

WHEREAS, California Health and Safety Code section 34270 authorizes the Mayor, subject to confirmation of a majority of the members of the Council, to appoint five commissioners; and

WHEREAS, California Health and Safety Code sections 34270 and 34272(d) provide (1) that the Mayor shall appoint, subject to the confirmation of a majority of the members of the Council, two additional commissioners who are tenants of the authority, one of whom shall be over 62 years of age if the authority has tenants of such age, and (2) that if a tenant commissioner ceases to be a tenant of the authority he/she shall be disqualified and another tenant shall be appointed to fill the unexpired term; and

WHEREAS, pursuant to California Health and Safety Code section 34272 the tenant commissioners' terms shall be two years; all other commissioners' terms shall be four years; and all vacancies shall be filled for the unexpired term; now therefore, be it

WHEREAS, in 2009 pursuant to Resolution No. 82300, the City Council confirmed the Mayor's appointment of Gregory Hartwig to the Oakland Housing Authority Board of Commissioners as follows:

**Gregory Hartwig**, reappointment to complete the term beginning July 1, 2009 and ending June 30, 2012, retaining the seat he currently holds; and

WHEREAS, the correct term for the seat that Commissioner Hartwig holds is fouryears, namely the term beginning on July 1, 2009 and ending on June 30, 2013; now therefore be it

**RESOLVED:** that Resolution No. 82300 C.M.S. hereby is amended to reflect that Gregory Hartwig's 2009 reappointment to the Oakland Housing Authority Board of Commissioners was to complete the four-year term beginning July 1, 2009 and ending June 30, 2013; and be it

**FURTHER RESOLVED:** that the City Clerk shall revise the roster for the City's boards and commissions, if necessary, to reflect the correct term for Commissioner Gregory Hartwig and the seat he holds.
