RESOLUTION AWARDING A CONTRACT TO FRANCISCO ELECTRIC, A CORPORATION, FOR THE PURCHASE OF STREET LIGHTING AND TRAFFIC SIGNAL STANDARDS IN THE ANNUAL AMOUNT NOT TO EXCEED EIGHT HUNDRED THIRTY FIVE THOUSAND DOLLARS (\$835,000.00) FOR THE PERIOD OF OCTOBER 1, 2011 TO OCTOBER 31, 2012 PER REQUEST FOR QUOTATION 1773-02, SPECIFICATION NO. 11-550-85-03 AND THE GENERAL CONDITIONS THEREFOR ON FILE IN THE PURCHASING DIVISION AND ACCORDING TO CONTRACTOR'S BID SUBMITTED JULY 20, 2011

WHEREAS, staff previously conducted two unsuccessful request for quotation (RFQ) processes for vendors to submit pricing for the purchase and supply of street lighting and traffic signal standards under RFQ 841 and RFQ 1773 for a term contract; and

WHEREAS, staff conducted a successful solicitation process under RFQ 1773-02 for these products in July and Francisco Electric Supply was deemed the lowest responsive, responsible bidder with a bid of eight hundred thirty five thousand dollars (\$835,000.00), annually; and

WHEREAS, the Council must reject bids submitted in response to RFQ 841 because bidders took exception to the contract period due to the volatility of the steel market, and RFQ 1773 because it was not properly advertised; now, therefore be it,

RESOLVED: That the Council hereby rejects all bids received in response to RFQ 841 and RFQ 1773; and be it

FURTHER RESOLVED: That a contract for the purchase and furnishing of Street Lighting And Traffic Signal Standards to the City of Oakland in an annual amount not to exceed eight hundred thirty five thousand dollars (\$835,000.00) from October 1, 2011 to October 31, 2012, in accordance with RFQ 1773-02 and the general conditions therefor on file in the Purchasing Section is hereby awarded to Francisco Electric Supply, according to its bid filed with the City on July 20, 2011; and, be it

FURTHER RESOLVED: That the Council hereby authorizes the City Administrator to extend all or part of the contract for an additional two-year period, one-year at a time, at the same prices, terms and conditions.
