A RESOLUTION ON BEHALF OF THE CITY OF OAKLAND, AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR, ACCEPT AND APPROPRIATE THE CHILD AND ADULT CARE FOOD PROGRAM (CACFP) GRANT FROM THE CALIFORNIA DEPARTMENT OF EDUCATION, NUTRITION SERVICES DIVISION, IN AN ESTIMATED AMOUNT OF FIVE HUNDRED FORTY FIVE THOUSAND DOLLARS (\$545,000) TO PROVIDE FUNDING FOR NUTRITIOUS MEALS TO ELIGIBLE CHILDREN ENROLLED IN THE OAKLAND HEAD START PROGRAM FOR PROGRAM YEAR 2012-2013

WHEREAS, the City of Oakland desires to apply for, accept and appropriate a Child Care Food Program (CCFP) Grant in an estimated amount of \$545,000 from the California Department of Education to fund a Head Start child nutrition program from September 1, 2012 through August 31, 2013; and

WHEREAS, the City's Fiscal Year (FY) 2012-2013 Adopted Budget includes \$545,000 in appropriations and revenues for FY 2012-2013 for the CCFP grant; and

WHEREAS, the California Department of Education Child Nutrition and Distribution Division will provide funds for comprehensive nutrition services to 1,061 Head Start children, who have the most economic need, with 10% of the enrollment consisting of children with special needs; and

WHEREAS, the City wishes to apply for, accept and appropriate the Child Care Food Program (CCFP) grant from the Department of Education in an estimated amount of five hundred forty five thousand dollars (\$545,000) for Head Start nutrition services; now, therefore, be it

RESOLVED: That the City Administrator or her designee as agent of the City of Oakland is hereby authorized and directed to submit on behalf of the City of Oakland an application to CCFP for funds to operate a Head Start Child Care Food Program for children in the City of Oakland from September 1, 2012 through August 31, 2013, and to execute and submit all documents, including but not limited to agreements, amendments, and payment requests which may be necessary to obtain funds to operate such a program and to accept said funds; and be it

FURTHER RESOLVED: That the City Administrator is hereby authorized and directed to appropriate any additional funding which may become available from this grant without returning to Council; and be it

FURTHER RESOLVED: That the sum of \$545,000 and offsetting revenue shall be appropriated to the Department of Agriculture Fund (2102), Head Start Organization (78231), and Head Start CCFP FY 12-13 Project (G4221) for the purpose of operating the Head Start Child Care Food Program.
