Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action for the sum of Seven Thousand Five Hundred Dollars and No Cents (\$7,500.00) payable to Marisela Mendoza and the Law Offices of Thomas W. Cain, her attorney.

This action arose when an Oakland Police Department vehicle in Code 3 struck Plaintiff Marisela Mendoza's minivan while she was making a **U**-turn in the 2400 block of 23rd Avenue on August 20, 2010. Plaintiff alleges the police car's siren was not on in the moments before the collision. Settlement of this matter is recommended to avoid the risk of a more adverse jury verdict. This was not a closed session item.


