#### **RECOMMENDATION**

Staff recommends that the City Council approve:

A City Resolution Authorizing the City Administrator to Negotiate and Execute a Project Labor Agreement with the Building and Construction Trades Council of Alameda County, AFL-CIO, and Specified Local Unions for the Construction of the City's Portions of the former Oakland Army Base Without Returning to the City Council

An Oakland Redevelopment Successor Agency (ORSA) Resolution Authorizing The ORSA Administrator To Negotiate And Execute A Project Labor Agreement With The Building And Construction Trades Council Of Alameda County, AFL-CIO, And Specified Local Unions For The Construction Of Public Improvements At The Former Oakland Army Base Without Returning To The ORSA Board

#### **EXECUTIVE SUMMARY**

On July 3, 2012, by way of Ordinance No. 13131 C.M.S., the City Council authorized a Design-Build contract with CCIG Oakland Global, LLC for the construction of public improvements at the Army Base. These public improvements will involve a large, complex, and multi-craft effort. To ensure the efficient progress of construction, City staff negotiated a Project Labor Agreement (PLA) with the Building Trades to (1) provide a peaceful, efficient, expedited and binding procedure for settling labor disputes without labor action or lockouts; (2) facilitate implementation of the Construction Jobs Policy for Public Improvements for the Oakland Army Base; (3) stabilize wages and working conditions; and (4) ensure an adequate supply of skilled craftspeople. The PLA references the terms of the Construction Jobs Policy, which is included as a material term of the Lease Disposition and Development Agreement with Prologis CCIG Oakland Global, LLC ("Developer"), and which will govern all construction work on for the Army Base. The City will apply this PLA as a contract specification of all construction contracts

awarded by the City and its Construction Manager for the public infrastructure and site preparation work that is required to the prepare the former Oakland Army Base site for commercial development.

#### **OUTCOME**

The PLA would constitute a cooperative effort of the Building Trades and the City toward establishing a stable working environment for the workers who will be employed in the construction of the public infrastructure for the Oakland Army Base, and ensuring that construction will proceed in an orderly manner. The City could realize cost savings from the labor peace. In addition, the PLA contains important provisions for the community, including key assistance by unions in advancing local hiring goals and apprenticeship requirements, ensuring that a significant number of Oakland residents will benefit from the City's investment in the revitalization of the Oakland Army Base.

#### BACKGROUND/LEGISLATIVE HISTORY

In 2008, the Redevelopment Agency (Agency) issued a Request for Proposals (RFP) for a master developer for the Oakland Army Base. Among the expectations for developing the property were that: project construction would provide training and employment opportunities for targeted residents; all general contractors on the project would be required to create and utilize a plan incorporating requirements of the City of Oakland Apprenticeship Policy and City of Oakland Local Hire Policy; and the proposer could be required to enter into a labor peace agreement and cause each Army Base employer also to sign a labor peace agreement.

The RFP defined a "labor peace agreement" as any written agreement which (a) waives the right of the labor organization and its members to engage in picketing, work stoppages, boycotts, or other economic interference with the Agency's proprietary interests in the premises for the duration of the Agency's lease; and (b) provides that any services to be performed by employees of the employer's tenants, subtenants, contractors, or subcontractors will also be done under agreements containing the same labor peace assurance. "Services" included janitorial, security, building and grounds maintenance, warehousing and distribution, industrial, mechanics and truck services, retail, hotel (and any restaurant connected thereto), and grocery sales.

These expectations were reiterated in the Community Benefits Term Sheet attached to the Exclusive Negotiating Agreement (ENA) the Agency entered into with the Developer for the development of the Army Base. During the course of negotiations with the Developer, the City Council determined that the City should develop a Community Benefits Agreement within which the City would negotiate and implement the suite of programs and features that address the wide array of goals and priorities the Army Base project must fulfill.

An Army Base Jobs Working Group consisting of representatives from West Oakland; community coalitions, such as OaklandWORKS and Revive Oakland!; the Building Trades Council of Alameda County, contractors, and the Developer came together to work on developing policies addressing job creation at the Army Base. The Working Group appointed a

The Working Group's consensus recommendation supported a PLA based on the following conditions:

- There will be a binding Community Jobs Agreement (CJA), which will serve as the overarching policy and program framework for construction and operations jobs. The CJA will be a third party agreement among the developers, the City, community stakeholders (representatives to be determined) and labor, and will provide signatories with legally enforceable rights and obligations.
- The CJA should be developed and approved prior to the City executing a PLA for the Army Base development to ensure that the PLA strengthens local hiring outcomes by completely supporting the goals and processes articulated in the CJA.
- The PLA for Army Base construction shall conform to the mutually agreed upon local hiring and program operations requirements within the CJA. The terms and conditions of a PLA among the Building Trades and the City, the CJA, and Army Base Development Agreements pertaining to projects on the City's portion of the Army Base will be aligned and consistent.
- The PLA must support and agree with the terms and conditions of an over-arching CJA, and must recognize and support the goals and policies of the CJA as a condition of approval for commencing infrastructure construction on City property.
- The City would enter into a PLA with the trade unions for the construction jobs.

The conditions for a PLA were incorporated into a set of recommendations from the Working Group that formed the basis of a Community Jobs Policy Framework for the Army Base. Staff first presented the Jobs Policy framework to the CED Committee on January 10, 2011, and further articulated it on January 24, 2012. The Community Jobs Policy Framework has guided the City's negotiation of (I) Jobs Policies regarding hiring and employment at the Army Base; (2) a Cooperation Agreement, which, among other things, commits the City to (i) ensure the Developer's compliance with the Jobs Policies, (ii) enter into a Project Labor Agreement (PLA) with the Building and Construction Trades Council for the publicly funded portion of Army Base construction, and (iii) require the Developer to enter into its own PLA with the Building Trades

for all other portions of project construction; and (3) a PLA, which secures labor peace during construction.

Staff presented a draft of the Cooperation Agreement and associated Community Jobs Policies to the City Council on June 19, 2012. By way of Resolution No. 83933 C.M.S. the Council authorized the City Administrator to negotiate and enter into the Cooperation Agreement with specified community and labor groups. In accordance with the Cooperation Agreement and the recommendations of the Working Group, staff has negotiated a PLA which is aligned with the terms and conditions of the Cooperation Agreement, including local hiring, and consistent with the Construction Jobs Policy. The most current information on the contents of the PLA will be provided in a supplemental report.

#### **ANALYSIS**

Since delays on any public construction project can be costly for the taxpayer, the PLA prevents such delays by barring strikes, lockouts and other work stoppages. It requires disputes to be submitted to impartial arbitration for resolution, saving taxpayers' money and insuring the project proceeds on time. Beyond requiring labor peace to protect its own interests, the City has no direct role in the relationships between business and labor. Actual labor peace discussions and negotiations should be among the unions and businesses.

The Army Base project must also consider the Port's contracting and hiring policies governed by the State Lands Commission and prescribed within its Maritime and Aviation Project Labor Agreement (MAPLA). The Port's Local Impact Area, for example, includes not only Oakland but also the cities of Alameda, Emeryville, and San Leandro. In addition, local policies and priorities, such as for contracting and hiring, may conflict with state and federal law and funding source guidelines and restrictions. State Prop 209, for example, usually prohibits race-based targeting to enhance participation of local minority and women owned businesses. The Department of Transportation Highway Administration (FHWA), which will likely be the largest source of federal funding for the Army Base infrastructure development project, does not typically support geographic targeting for local business outreach or local hiring for that matter. There are, however, examples of projects for which funding recipients have negotiated contract terms with FHWA to help meet local contracting and hiring priorities.

#### PUBLIC OUTREACH/INTEREST

The Army Base Jobs Working Group meetings, facilitated by Councilmember Brunner and her staff, occurred from December 2010 through October 2011. This group held nine meetings over the course of the period. The meetings were open to anyone wishing to weigh in on developing a comprehensive set of goals, conditions and implementation processes regarding local hiring for

The Working Group consisted of representatives from West Oakland; community coalitions, such as OaklandWORKS and Revive Oakland!; the Building Trades Council of Alameda County, contractors, and the Developer.

#### COORDINATION

In addition to the community-based and labor groups, staff coordinated with the City Administrator's Contract Compliance Office.

#### COST SUMMARY/IMPLICATIONS

A conservative estimate for staff costs for on-going monitoring and compliance per annum is \$300,000 - \$450,000 for the entire project at its peak.

Potential sources of revenue to fund these costs include:

- a) West Oakland Community Fund
  This Fund is expected to generate up to \$2,000,000 based on a one-time payment of
  \$16,000 per developable leased and sold acre of land on the over the next two to seven
  years. The West Oakland Community Advisory Group has presented a number of
  recommendations for the use of these funds. The City Council has the ultimate authority
  over how these funds are allocated.
- b) Billboard revenue
  The City's share of proposed Army Base billboard plan could be as high as \$490,000
  annually beginning in 2014. With expedited approvals, a portion of these estimated funds
  could be available sooner.
- c) Special Development Fee in lieu of the Jobs/Housing Impact Fee
  The current Jobs Housing Impact Fee could be waived and a new in lieu fee could be
  approved based on a commercially viable per square foot basis. Staff has no estimate at
  this time for this potential source of one time funding, and recommends that the City
  Council consider the option.
- d) Commercially Viable Community fee on tenants

  This fee based on square footage leased to master developer tenants would not be
  available until 2016 and beyond, and may amount to approximately \$50,000 per year by
  2019.
- e) Possessory interest (property taxes) targeted to support OAB Community Benefits

The City Council could elect to divert a portion of the possessory interest generated by the Army Base project for Community Benefits. This option is also out in the future when there is new development and property values increase substantially.

#### **SUSTAINABLE OPPORTUNITIES**

Economic: A Project Labor Agreement between the Building Trades and the City will ensure that there are no costly work stoppages or disruptions during the construction phase: The Labor Peace provision for the operations jobs has the same intent of protecting the City's financial interests as well as ensuring that workers are not at risk of losing wages due to work stoppages and disruptive labor disputes.

Environmental: This report does not directly address environmental sustainability.

**Social Equity**: A PLA sets out uniform and fair working conditions and advanced the purposes of the Construction Jobs Policy.
