<u>RECOMMENDATION</u>

Staff recommends that the City Council adopt the resolution accepting and confirming reports of the City Administrator on the costs incurred by the City Of Oakland for delinquent garbage service fees and confirming the recordation of liens with administrative and assessment charges as necessary – pursuant to Chapter 8.28 of the Oakland Municipal Code, and directing the notice of lien and assessment charges be turned over to the County Tax Collector for collection.

OUTCOME

25 cases were resolved and removed from the list of delinquent properties. A resolution has been prepared confirming the placement of liens on 7,655 accounts (a list of delinquent accounts is available for review in the Office of the City Clerk, 1st floor City Hall) and authorizing the subsequent assessment for all fees and charges, should they remain unpaid at the time of submission to the County Assessor.

BACKGROUND/LEGISLATIVE HISTORY

Pursuant to Chapter 8.28 of the Oakland Municipal Code, administrative hearings were held to hear protests and resolve any inconsistencies or inequities regarding the delinquent mandatory garbage fees prior to the public hearing before City Council.

ANALYSIS

Waste Management of Alameda County billed the City \$1,057,120 which represents monthly charges for April through June 2012, and quarterly charges for July through September 2012. The bill is due and payable after the public hearing proceedings. Property owners owe the City delinquent garbage charges totaling \$1,057,120 and administrative fees totaling \$541,949 creating a grand total of \$1,599,069 for this period. The City will transfer all unpaid charges and fees to the Alameda County Tax Roll, and payments received through the County will be deposited in the City's Mandatory Garbage Fund (1700).

PUBLIC OUTREACH/INTEREST

On, August 7, 2012, pursuant to Chapter 8.28 of the Oakland Municipal Code, an administrative hearing was held to hear protests and resolve any inconsistencies or inequities prior to this public hearing before the City Council. Each affected property owner was notified of the administrative hearing.

COORDINATION

In coordination with the Office of the City Attorney, the agenda report, resolutions, and support items attached to this form have been reviewed and/or approved for form and legality.

In coordination with the **B**udget Office, the agenda report, resolutions, and support items attached to this form have been reviewed for Fiscal Impact(s) and / or Funding Codes.

COST SUMMARY/IMPLICATIONS

If the City fails to place liens to recover the delinquent garbage charges, the City's Mandatory Garbage Fund (1700) may potentially lose a grand total of \$1,599,069 for this period.

SUSTAINABLE OPPORTUNITIES

<u>Economic:</u> Collections of delinquent garbage charges have major economic implications for the City's sustainability. The revenue source is relied upon to fund essential City services.

<u>Environmental</u>: There are no environmental opportunities resulting from the recordation of liens.

<u>Social Equity:</u> Collections of delinquent garbage charges have significant social equity implications for the City's sustainability. The revenue source is relied upon to fund essential City services to all citizens and taxpayers.
