October – Mid- November	BUSINESS IMPROVEMENT DISTRICTS	 In September/October the BID program compiled and began review of annual reports and proposed FY 13/14 budgets for 6 BIDs (Rockridge, Montclair, Downtown Oakland, Lake Merritt/Uptown, Koreatown/Northgate, and Fruitvale) for forwarding to City Council in Nov-Dec. 2012. Staff is supporting the exploration and formation efforts of new business assessment districts in: Jack London District, Dimond District and the Airport Area Business Park area. Meetings were held with 3 stakeholder groups. Staff also provided other services in support of districts. Staff attended the Oakland CBD Board meeting and worked with them on retail recruitment, surveys, Staff met with KONO and planned broker tour of area. Staff attended the monthly BID Council meeting. The Lakeshore Property Based Improvement District renewal was completed. Staff participated in 3 meetings of the Oakland CBD/BID Managers Council, arranging speakers including OPD and Revenue Division. Staff attended the KONO Board meeting, Lake Merritt Uptown District and Downtown Oakland District Board meetings.
	GRANTS & BROADWAY SHUTTLE	 Initiated effort to study cost and benefits of upgrading the Broadway Shuttle to an electric Streetcar. The study is being funded with a \$300,000 Caltrans grant secured by Economic Development staff 56,613 passengers used the Broadway Shuttle during the month of October. These passengers stimulated economic activity in Oakland by spending approximately \$738,333 at restaurants and other business along the route.

	 To generate an additional boost to local and attract new business, ED staff began planning this month to expand shuttle hours until 10pm on weekdays. This expansion will be funded using a \$723,000 grant secured by Economic Development staff from the MTC and ACTC. BROWNFIELDS- Calreuse re-allocation program under consideration by the State, pending budget. Initial preparation of application for the Foreign Trade Zone Alternative Site Framework application to the Foreign Trade Zone Board of the US Department of Commerce. SPECIFIC PLANS	Specific Plans Staff facilitated Economic Development issues. Staff participated in the review of the Draft Plan and Scoping Proposal for the EIR for the West Oakland; gave feedback on the Broadway Valdez Plan draft, and is working with Planning Staff on the Lake Merritt Plan.
