# **RECOMMENDATION**

Staff recommends that the City Council approve an Ordinance Amending the Salary Schedule Of Ordinance No. 12187 C.M.S. ("Salary Ordinance") to Make Corrections to Ordinance No. 13125 C.M.S. and Ordinance No. 13130 C.M.S.

# **OUTCOME**

City Council adopted Ordinance No. 13125 C.M.S. on June 19, 2012 (*Attachment A*) which authorized the addition of the classification of Neighborhood Law Corps Attorney to the Salary Schedule of Ordinance No. 12187 C.M.S. (the Salary Ordinance), however the salary amount of \$40,000 per year (\$3333.34 per month) was stated incorrectly in the ordinance document and should have been \$42,000 per year (\$3500 per month). The proposed ordinance seeks to correct the error. City Council also adopted Ordinance No. 13130 C.M.S. on July 3, 2012 (*Attachment* **B**) which authorized the addition of the classification of Sewer Maintenance Planner to the Salary Schedule of Ordinance No. 12187 C.M.S. (the Salary Ordinance), however the bargaining unit assignment and biweekly hours schedule were stated incorrectly. The proposed ordinance seeks to correct the error.

Unless the record is corrected, the classifications of Neighborhood Law Corps Attomey and Sewer Maintenance Planner caumot be implemented as adopted. Staff recommends that City Council adopt the revised ordinance to make the necessary corrections and amend the Salary Ordinance as originally intended.

# BACKGROUND/LEGISLATIVE HISTORY

The Salary Ordinance was amended by Ordinance No. 13125 C.M.S. to add the classification of Neighborhood Law Corps Attomey to provide the Office of the City Attomey with an

Item: \_\_\_\_\_ Finance & Management Committee December 11, 2012 appropriate classification for the work performed as part of the Neighborhood Law Corps Program. Implementing the new classification has been delayed pending correction to the salary rate.

The Salary Ordinance was also amended by Ordinance No. 13130 C.M.S. to add the classification of Sewer Maintenance Planner. Implementing the new classification has been delayed pending correction to the bargaining unit and biweekly hours schedule.

# ANALYSIS

The lawyers hired for the Neighborhood Law Corps Program are currently classified as Exempt Limited Duration Employees (ELDEs), but that classification is not appropriate because the Civil Service Rules require that ELDEs serve terms limited to one year and the attomeys in the Neighborhood Law Corps Program serve terms not to exceed three years. The addition of the new classification to the Salary Ordinance provided a Rules-compliant method of engaging attomeys for the program. The Sewer Maintenance Planner classification is needed to allow the City to comply with the Environmental Protection Agency's (EPA) Administrative Order (AO) to take specific actions related to the City's wastewater collection system.

# PUBLIC OUTREACH/INTEREST

The Civil Service Board is responsible for the City's classification plan and all classification specifications must be approved by the Board prior to inclusion in the City's plan. The proposal to add the classifications of Neighborhood Law Corps Attomey and Sewer Maintenance Planner were posted publicly in conformance with the Sunshine Ordinance and Brown Act prior to the Civil Service Board's review of the items at its meetings. The classification of Neighborhood Law Corps Attomey is exempt from Civil Service and is unrepresented. Local 21 represents the Sewer Maintenance Planner classification and staff met with the union prior to the classification being presented to the Civil Service Board for inclusion in the City's classification plan. The union had no objections and the Board adopted the classification.

# **COORDINATION**

DHRM coordinated the creation of the classification specifications with the respective departments, the Civil Service Board, and the representative union.

# **COST SUMMARY/IMPLICATIONS**

There are no new costs associated with the proposed actions of correcting the salary schedule for Neighborhood Law Corps Attomey and Sewer Maintenance Planner. Amending the classifications will serve to provide appropriate titles for work that is already budgeted.
