WHEREAS, Centro de Juventud is a youth center dedicated to the prevention of the use of drugs and alcohol by youth between the ages of 7 -18 years; and

WHEREAS, Centro de Juventud conducts family needs assessments and provides parenting workshops, supportive services and problem identification and referrals for parents and other family members; and

WHEREAS, the City will require The Latino Commission On Alcohol And Drug Abuse Of Alameda County, Centro De Juventud Program to provide documentation for use of the Councilmember's priority project funds; now, therefore, be it
