## A Resolution Honoring The Clorox Company on Its Centennial

**WHEREAS**, The Clorox Foundation in 2012 helped nearly 100 organizations reach more than 26,000 young people in Oakland and the surrounding area. Clorox volunteers also play an important role supporting the community with their time, expertise, money and passion; and

**WHEREAS**, The Clorox Company moved its headquarters from High Street to 1221 Broadway in Oakland City Center, a cornerstone of the city's urban renewal in 1976; and

WHEREAS, The Clorox Company brought its headquarters building up to Leadership in Energy and Environmental Design (LEED) Platinum "green building" status in 2010, a rare achievement for an existing building from an earlier era; and

WHEREAS, In 2012, Clorox announced the sale of the building while retaining the company headquarters there through a long-term leaseback arrangement; and
