WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, the Honorable Mayor Jean Quan has appointed Ekaterina Burton as a Mayoral representative and Venus Johnson on the recommendation of Council President Pat Kernighan and Christian Garcia on the recommendation of Councilmember Noel Gallo and has reappointed Alexandria (Dria) Fearn on the recommendation of the Chairperson of the Community and Economic Development Committee, each to serve a two year term on the Budget Advisory Committee subject to confirmation by the City Council; now therefore be it
