WHEREAS, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S.) state that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; now, therefore be it

RESOLVED, that Councilmember Lynette Gibson McElhaney is hereby appointed to the East Bay Economic Development Alliance's Executive Committee, commencing July 1, 2013 and ending June 30, 2014; and be it FURTHER RESOLVED, that President Pro Tem Rebecca Kaplan is hereby appointed as alternate to the East Bay Economic Development Alliance's Executive Committee, commencing July 1, 2013, and ending June 30, 2014.
