AN ORDINANCE AMENDING ORDINANCE NUMBER 13133 C.M.S. (THE FY 2012-13 MASTER FEE SCHEDULE, OR "MFS"), TO ESTABLISH, MODIFY AND DELETE FEES AND PENALTIES ASSESSED BY THE OFFICE OF THE CITY ADMINISTRATOR, THE CITY ATTORNEY'S OFFICE, THE FINANCE AND MANAGEMENT AGENCY, THE OAKLAND POLICE DEPARTMENT, THE OAKLAND FIRE DEPARTMENT, THE OAKLAND PUBLIC LIBRARY, THE OFFICE OF PARKS AND RECREATION, THE DEPARTMENT OF HUMAN SERVICES, THE PUBLIC WORKS AGENCY, THE DEPARTMENT OF HOUSING & COMMUNITY DEVELOPMENT AND THE DEPARTMENT OF PLANNING & BUILDING.

WHEREAS, the City of Oakland periodically updates its Master Fee Schedule to account for general cost of living increases and program changes or other costs; and

WHEREAS, the fee modifications and additions proposed herein have been justified by the respective agencies and are identified in an "Agenda Report" dated May 1, 2013 to Deanna 1. Santana, City Administrator, entitled "An Ordinance Amending Ordinance Number 13133 C.M.S. (Master Fee Schedule), as Amended, to Establish, Modify, and Delete Fees Assessed by selected Offices, Departments, and Agencies of the City of Oakland"; and

WHEREAS, the City Council finds and determines that the herein-referenced modifications and additions are necessary to reimburse the City for the costs of performing the various municipal and regulatory functions; and

WHEREAS, a Public Hearing was held on June 4, 2013, to review the proposed fee changes; now, therefore

## THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

Section L The Master Fee Schedule as set forth in Ordinance Number 13133 C.M.S., as amended, is hereby amended to modify and establish fees assessed by Citywide, the City Administrator's Office, the Office of the City Attorney, the City Clerk's Office, Information

Technology, the Finance & Management Agency, the Administrative Services Department, the Oakland Police Department, the Oakland Fire Department, the Community Services Department (Parks & Recreation and Human Services), the Library Public Library, Community & Economic Development Agency, the Department of Housing & Community Development, and the Department of Planning & Building and as set forth in Exhibit A, attached hereto and made a part hereof.

Section 2. This ordinance shall be effective on July 1, 2013 upon approval by the Council of the City of Oakland.
