# **RECOMMENDATION**

Staff recommends that the City Council approve a resolution authorizing the City Administrator to award a contract to Bear Data Solutions Technology, a local business, in an amount not to exceed five hundred fourteen thousand, four hundred forty-three dollars and ninety-four cents (\$514,443.94) to upgrade the City's Integrated Public Safety System (IPSS) Network in accordance with Specification No. 13-204-91/RFQ No. 4492.

### **OUTCOME**

The City will award a contract to Bear Data Solutions Technology to upgrade the City's Integrated Public Safety System (IPSS) Network in an amount not to exceed \$514,443.94. This mission critical upgrade is for the Oakland Police Department that supports key safety functions such as the Computer Aided Dispatch (CAD) System and Field Based Reporting. Upgrading the IPSS with new equipment, covered by warranties and maintenance contract is essential to the safety of Citizen and first responders.

# BACKGROUND/LEGISLATIVE HISTORY

Specification No.13-204-91/RFQ No. 4492 to upgrade the City's Integrated Public Safety System (IPSS) Network was sent to one local business enterprise and three non-local business enterprises. Purchasing advertised this requirement in the City's official newspaper in accordance with Oakland Municipal Code (CMC) 2.04.050, and posted on the City's website. On March 28, 2013, the City received one bid from a local business enterprise. Based on the information provided in response to **R**FQ 4492, Bear Data Solutions Technology, a local business, was deemed the lowest responsible bidder.

# ANALYSIS

The Department of Information Technology is preparing to upgrade the Core Integrated Public Safety (IPSS) Network Equipment. Currently the City has a distributed redundant Public Safety

Item: \_\_\_\_\_ Finance and Management Committee July 23, 2013 Core Network. This Network serves multiple sites including the Emergency Operation Center, Police Administration Building and 911 Operations Center. This is a pivotal communications network for the City's first responders. The network supports key public safety functions such as Computer Aided Dispatch and Field Based Reporting. The proposed upgraded network will provide additional capacity to support the increased demands of voice/data and rich multimedia applications.

The existing equipment in the Integrated Public Safety Network is over 10 years old. Due to its age, the mean time between failures of the currently deployed equipment is reaching unacceptable levels. Cisco Systems, the equipment manufacturer, no longer offers maintenance, warranties or support for this equipment since November 2012. The system's current condition has a direct impact on the safety of citizens and first responders. Upgrading the IPSS equipment with new equipment, covered by warranties and a maintenance contract is essential to the ongoing support of emergency response applications over the network. The upgrade of the proposed equipment in the Public Safety Network will have a direct impact on the network's performance and reliability, as well as the critical applications it supports.

#### PUBLIC OUTREACH/INTEREST

This item did not require any additional public outreach other than the required posting on the City's website and in the City's official newspaper.

### COORDINATION

Purchasing worked with the Department of Information Technology, Oakland Police Department, Budget Office and City Attorney's Office. The staff report was provided to the Compliance Director for review and feedback.
