### **HONORING THE OAKLAND LODGE ON THE OCCASION OF ITS HOSTING THE CHINESE AMERICAN CITIZENS ALLIANCE'S 52ND BIENNIAL CONVENTION**

**WHEREAS**, the Oakland Lodge of the Chinese American Citizens Alliance was founded on June 21, 1912 by 22 charter members, originally established for the purposes of fighting for civil rights, justice, equality and the welfare of Chinese Americans; and

**WHEREAS**, the Oakland Lodge promotes and supports voter registration and education, community volunteerism in partnership with the Oakland Police and Fire Departments for events, program activities and sponsorship of programs like Lincoln Park security cameras, the installation of the first traffic lights in Chinatown, and Chinatown clean-ups; and

**WHEREAS**, the Oakland Lodge is dedicated to the education of youth and to providing Merit Scholarship to qualified students who have demonstrated community leadership skills, have strong academic performances, and are in financial need; and

**WHEREAS**, the Oakland Lodge sponsored youth to summer camps and leadership conferences to train the next generation for involvement in local, State and Federal government; and

**WHEREAS**, the Oakland Lodge plays an important role in community development, sponsoring events in Oakland Chinatown, such as the Independence Day Celebration, a celebration honoring veterans, Oakland Police Appreciation Day, representation in the Mayor's Town Hall, and established the well-known Tai Chi and line dancing classes at the Lincoln Recreation Center; and

**WHEREAS**, the Oakland Lodge has been involved in the Pagoda Project, the Lincoln Park Restoration Project, the 10,000 Steps Project as well as Chinese Garden, Kee Ying Senior Center, and a documentary film about Angel Island community projects; and

**WHEREAS**, the Oakland Lodge is hosting the 52 Biennial Convention of the Chinese American Citizens Alliance in Oakland on Saturday, August 10, 2013; now, therefore be it

**RESOLVED:** That the Oakland City Council hereby honors the Oakland Lodge for its many contributions to the community and on the occasion of its hosting the 52nd Biennial Convention of the Chinese American Citizens Alliance.


