RECOMMENDATION

Staff recommends that the City Council adopt:

Resolution Amending And Restating A Previously Approved Conditional And Revocable Major Encroachment Permit To Kaiser Foundation Hospitals To Allow (1) Telecommunications Conduits, Electrical Transformers And Vaults, A Portion Of A Building Foundation And Sewage Storage Vault For Phase II Buildings At 275 West MacArthur Boulevard To Encroach Under The Public Right-Of-Way Along Broadway, West MacArthur Boulevard, And Piedmont Avenue, And (2) Soil Nailing, A Planter Box, Rectangular Curb Drains, The Foundation For A Gate Post, Six Benches, Four Trash Cans, Four Sanitary Sewer Manholes And A Concrete Driveway Approach With Non-Standard Color At 3600 Broadway To Encroach Into The Public Right-Of-Way Along Broadway, MacArthur Boulevard, And Piedmont Avenue

OUTCOME

The resolution will authorize the City Engineer to amend and restate a previously approved major encroachment permit for the proposed (1) telecommunications conduits, electrical transformers and vaults, a portion of a building foundation and sewage storage vault for Phase II buildings at 275 West MacArthur Boulevard, and (2) soil nailing, a planter box, rectangular curb drains, the foundation for a gate post, six benches, four trash cans, four sanitary sewer manholes and a concrete driveway approach with non-standard color at 3600 Broadway.

BACKGROUND/ LEGISLATIVE HISTORY

On January 18, 2011, the City Council passed Resolution No. 83154 C.M.S., which granted property owner Kaiser Foundation Hospitals ("Permittee") a revocable and conditional permit (no.

ENMJ 07176¹) to allow telecommunications conduits, electrical transformers and vaults, and a portion of a building foundation and sewage storage vault for Phase II buildings at 275 West Macarthur Boulevard to encroach under the public right-of-way along Broadway, West Macarthur Boulevard, and Piedmont Avenue. Permittee constructed these encroachments pursuant to an infrastructure permit (PX0900062):

Permittee has been granted a building permit (no. B1004593) to construct a new building at 3600 Broadway and an infrastructure permit (no. PX0900062) to construct public infrastructure improvements adjoining 3600 Broadway. As part of said building and infrastructure permits, Permittee has constructed the soil nailing, a planter box, rectangular curb drains, the foundation for a gate post, six benches, four trash cans, four sanitary sewer manholes and a concrete driveway approach with non-standard color. Permittee seeks to amend and restate Permit No. ENMJ 07176 to include these additional encroachments.

ANALYSIS

Oakland Municipal Code ("OMC") section 12.08 provides guidelines for the City's issuance of encroachment permits in the public right-of-way. A major encroachment is defined as "anything attached to a structure or constructed in place so that it projects into the public right-of-way." The Proposed Encroachments constitute both major and minor encroachments into the public right-of-way. OMC section 12.08.040 requires that major encroachments in the public right-of-way receive approval by resolution of the City Council before a permit may be issued.

Based on staff s review of the plans and investigation of the site of the Proposed Encroachments, the Proposed Encroachments will not interfere with public use of the roadway, sidewalk or buried utilities, and will not endanger the public welfare and convenience during said public use. The City Council has previously approved similar existing encroachments throughout Oakland.

The City Council's resolution constitutes a conditional revocable permit for encroachment, which shall take effect upon compliance of all conditions set forth therein. Such permit shall remain in effect as long as the Permittee complies with all conditions established for the granting of such permit, and shall become null and void upon the failure of the Permittee to comply with such conditions, or upon a termination by resolution of the City Council as being in the City's best interest.

PUBLIC OUTREACH/ INTEREST

This item does not require any additional public outreach other than the required posting on the City's website.

COORDINATION

The Office of the City Attorney has reviewed the resolution for form and legality, and the City Budget Office has reviewed this report.

COST SUMMARY/ IMPLICATIONS

Staff costs for processing the proposed encroachment permit are covered by fees set by the Master Fee Schedule and have been paid by the property owner and were deposited in the special revenue Development Service Fund (2415), Engineering Services Organization (88432), Encroachment Permits Account (42314), Engineering and Architectural Plan Approval (PS30). Pursuant to OMC section 12.08.120, the standard conditions of the encroachment permit require Permittee, at its own expense, to maintain liability and property damage insurance at all times during the period for which the permit is in effect, and to include the City as a named insured.

SUSTAINABLE OPPORTUNITIES

Economic: Construction of the Proposed Encroachments will provide opportunities for construction related jobs for the Oakland community.

Environmental: Construction permits for public right-of-way improvements require that Permittee comply with City ordinances and regional Best Management Practices for reducing nuisance noise, fugitive dust, construction debris disposal, and storm drainage pollutant runoff.

Social Equity: The Proposed Encroachments into the public right-of-way will have no adverse impact on the economic revitahzation of Oakland. Construction permits for improvements in the public right-of-way require that Permittee comply with State and City requirements for handicapped accessibility.

CEQA

On June 27, 2006, the City Council approved Resolution No. 80103 C.M.S. certifying the Environmental Impact Report, SCH No. 2005032134 (the "EIR"), for the Kaiser Permanente Oakland Medical Center Master Plan. Amending and restating major encroachment permit no. 07176, which authorizes the Proposed Encroachments to encroach into the public right-of-way, will not result in any significant environmental effect that has not already been analyzed in the EIR, and there will be no significant environmental effects caused by the change that have not already been analyzed in the EIR.

RESOLUTION AMENDING AND RESTATING A PREVIOUSLY APPROVED CONDITIONAL AND REVOCABLE **ENCROACHMENT PERMIT TO KAISER FOUNDATION HOSPITALS** TO ALLOW (1) TELECOMMUNICATIONS CONDUITS, ELECTRICAL TRANSFORMERS AND VAULTS, A PORTION OF A BUILDING FOUNDATION AND SEWAGE STORAGE VAULT FOR PHASE II **BUILDINGS MACARTHUR BOULEVARD** AT 275 WEST **ENCROACH UNDER** THE **PUBLIC RIGHT-OF-WAY** ALONG BROADWAY, WEST MACARTHUR BOULEVARD, AND PIEDMONT AVENUE, AND (2) SOIL NAILING, A PLANTER BOX, RECTANGULAR CURB DRAINS, THE FOUNDATION FOR A GATE POST, SIX BENCHES, FOUR TRASH CANS, FOUR SANITARY MANHOLES AND A CONCRETE DRIVEWAY APPROACH WITH NON-STANDARD COLOR AT 3600 BROADWAY TO ENCROACH INTO THE BROADWAY, **PUBLIC RIGHT-OF-WAY ALONG MACARTHUR** BOULEVARD, AND PIEDMONT AVENUE

WHEREAS, Kaiser Foundation Hospitals, a California corporation (no. C0224971), is the owner of real property known as 3600 Broadway, delineated as Parcel A on Parcel Map 9831 recorded November 18, 2011, Book 318, Page 52, by the Alameda County Clerk-Recorder, and identified by the Alameda County Assessor as APN 012-1024-001-00, and more particularly delineated diagrammatically in *Exhibit A*, attached hereto and incorporated herein, and 275 West MacArthur Boulevard and described in grant deeds recorded October 23, 1961, series no. AS13102, September 10, 1997, series no. 97233768, October 28, 2004, series no. 2004483317, September 1, 1988, series no. 88223179, October 29, 2004, series no. 2004486235, September 1, 1988, series no. 97233768, December 12, 2005, series no. 2005527230 and more particularly delineated diagrammatically in *Exhibit* B, attached hereto and incorporated herein; and

WHEREAS, on January 18, 2011, the City Council passed Resolution No. 83154 C.M.S., which granted Kaiser Foundation Hospitals ("Permittee") a revocable and conditional major encroachment permit to allow telecommunications conduits, electrical transformers and vaults, and a portion of a building foundation and sewage storage vault for Phase II buildings at 275 West MacArthur Boulevard to encroach under the public right-of-way along Broadway, West MacArthur Boulevard, and Piedmont Avenue ("Previous Encroachments"); and

WHEREAS, Resolution No. 831354 C.M.S. inadvertently referred to an incorrect encroachment permit number (no. 100062), and the correct encroachment permit number is ENMJ 07176; and

WHEREAS, Permittee constructed the Previous Encroachments pursuant to an infrastructure permit (PX0900062), the limits of which are delineated in *Exhibit C* attached hereto and incorporated herein; and

WHEREAS, Permittee has obtained a building permit (no. B1004593) to construct a new building at 3600 Broadway and an infrastructure permit (no. PX0900062) for construction of public-right-of-way improvements adjoining 3600 Broadway; and

WHEREAS, as part of said building and infrastructure permits, Permittee has constructed the soil nailing, a planter box, rectangular curb drains, the foundation for a gate post, six benches, four trash cans, four sanitary sewer manholes and a concrete driveway approach with non-standard color at 3600 Broadway, which encroach into the public right-of-way along Broadway, MacArthur Boulevard and Piedmont Avenue ("Current Encroachments", and together with the Previous Encroachments, the "Proposed Encroachments"), the limits of which are delineated in *Exhibit D*, attached hereto and incorporated herein; and

WHEREAS, Permittee seeks to amend and restate major encroachment permit number ENMJ 07176 to include the Current Encroachments; and

WHEREAS, staff has determined, based on review of the plans and investigation of the site of the Proposed Encroachments, said Proposed Encroachments in the public right-of-way and their locations will not interfere with public use of the roadway, sidewalk or buried utilities, and will not endanger the public welfare and convenience during said public use; and

WHEREAS, on June 27, 2006, the City Council approved Resolution No. 80103 C.M.S. certifying the Environmental Impact Report, SCH No. 2005032134 (the "EIR"), for the Kaiser Permanente Oakland Medical Center Master Plan; and

WHEREAS, the City Council hereby finds and determines on the basis of substantial evidence in the record that none of the circumstances necessitating preparation of additional environmental review, as specified in CEQA and the CEQA Guidelines, including, without limitation, Public Resources Code Section 21166 and CEQA Guidelines Sections 15162 and 15163, are present in that (1) there are no substantial changes proposed in the project or the circumstances under which the project is undertaken that would require major revisions of the EIR due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects; and (2) there is no "new information of substantial importance," as defined in CEQA Guidelines Section 15162(a)(3); and

WHEREAS, each as a separate and independent basis, this action is exempt from CEQA pursuant to CEQA Guidelines sections 15268(b) (ministerial projects), 15301 (existing facilities), 15303 (new construction of small structures), 15311 (accessory structures), 15183 (projects consistent with General Plan and Zoning), and 15061(b)(3) (no significant effect on the

environment); now, therefore, be it

RESOLVED: That the City Council has reviewed all relevant documents relating to the amendment and restatement of major encroachment permit number ENMJ 07176 that is the subject of this resolution; and be it

FURTHER RESOLVED: That the City Council tinds and determines that the decision made hereby is made in conformance with the requirements of CEQA; and be it

FURTHER RESOLVED: That the City Council hereby amends and restates the conditional revocable major encroachment permit (no. ENMJ 07176) previously granted to Permittee to allow (1) telecommunications conduits, electrical transformers and vaults, and a portion of a building foundation and sewage storage vault for Phase II buildings at 275 West MacArthur Boulevard to encroach under the public right-of-way along Broadway, West MacArthur Boulevard, and Piedmont Avenue, as set forth in *Exhibit C*, and (2) soil nailing, a planter box, rectangular curb drains, the foundation for a gate post, six benches, four trash cans, four sanitary sewer manholes and a concrete driveway approach with non-standard color at 3600 Broadway to encroach into the public right-of-way along Broadway, MacArthur Boulevard and Piedmont Avenue as set forth in *Exhibit D*, and according to the permit conditions set forth below; and be it

FURTHER RESOLVED: That said major encroachment permit is hereby conditioned by the following special requirements:

- 1. The Permittee is responsible for the relocation of all existing public utilities including but not limited to tire alarm, cable, master signal cable, street lighting and intersection signal cable, as required.
- 2. This agreement may be voided and the associated permit for encroachments may be revoked at any time and for any reason, at the sole discretion of the City Council, expressed by resolution as being in the City's best interest, or the associated permit may be suspended at any time, at the sole discretion of the City Engineer, upon failure of the Permittee to comply fully and continuously with each and all of the conditions set forth herein and in the associated permit.
- 3. The Permittee hereby disclaims any right, title, or interest in or to any portion of the public right-of-way, including the sidewalk and street, and agrees that the encroachment is granted for an indeterminate period of time and that the use and occupancy by the Permittee of the public right-of-way is temporary and does not constitute an abandonment, whether expressed or implied, by the City of Oakland of any of its rights associated with the statutory and customary purpose and use of and operations in the public right-of-way.
- 4. The Permittee shall maintain fully in force and effect, at its own expense, at all times during the period for which the permit is in effect, good and sufficient public liability insurance in a face amount not less than \$2,000,000.00 for each occurrence, and property damage insurance in a face amount not less than \$1,000,000.00 for each occurrence, both including contractual liability, insuring the City of Oakland, its officers, agents, employees, and volunteers against any and all claims arising out of the existence of the encroachment in the public right-of-way,

as respects liabilities assumed under this permit. The policy shall contain an endorsement declaring the policy as primary coverage on said liabilities. The Permittee shall submit a written certificate of such insurance or copy of the policy to the City Engineer showing that insurance is in effect in compliance with this section, and shall file subsequent notices of the renewal thereof with the City Engineer. Such certificate shall state that the insurance coverage shall not be canceled, amended or be permitted to lapse without thirty (30) days' prior written notice to the City Engineer. The Permittee also agrees that the City Engineer, at his or her sole discretion, may review the type and amount of insurance required of the Permittee amount of and/or change the type of insurance coverage required as circumstances warrant.

- 5. The Permittee shall be solely and fully liable and responsible for the repair, replacement, removal, reconstruction, and maintenance of any portion or all of the private improvements constructed or installed in the public right-of-way, whether by cause, neglect, or negligence of the Permittee or others, and for the associated costs and expenses necessary to restore or remove the encroachment to the satisfaction of the City Engineer, and shall not allow the encroachment to become a blight or a menace or a hazard to the health and safety of the general public.
- 6. The Permittee acknowledges and agrees that the encroachment is out of the ordinary and does not comply with City of Oakland standard installations. The Permittee further acknowledges and agrees that the City of Oakland and public utility agencies will periodically conduct work in the public right-of-way, including excavation, trenching, and relocation of its facilities, all of which may damage the encroachment. The Permittee further acknowledges and agrees that the City and public utility agencies take no responsibility for repair or replacement of the encroachment which may be damaged by the City or its contractors or public utility agencies or their contractors. The Permittee further acknowledges and agrees that upon notification by and to the satisfaction of the City Engineer, Permittee shall immediately repair, replace, or remove, at the sole expense of the Permittee, all damages to the encroachment that are directly or indirectly attributable to work by the City or its contractors or public utility agencies or their contractors.
- 7. The Permittee shall remain liable for and shall immediately reimburse the City of Oakland for all costs, fee assessments, penalties, and accruing interest associated with the City's notification and subsequent abatement action for required maintenance, repairs, or removal, whether in whole or in part, of the encroachment or of damaged City infrastructure made necessary by the failure, whether direct or indirect, of the Permittee to monitor the encroachment effectively and accomplish preventative, remedial, or restorative work expeditiously. The City reserves the unqualified right to collect all monies unpaid through any combination of available statutory remedies, including recordation of Prospective Liens and Priority Liens/ Special Assessments with the Alameda County Recorder, inclusion of non-reimbursed amounts by the Alameda County Assessor with the annual assessment of the general levy, and awards of judgments by a court of competent jurisdiction.
- **8.** Upon revocation of the encroachment permit, the Permittee shall immediately, completely, and permanently remove the encroachment from the public right-of-way, repair any damage

- resulting therefrom, and restore the public right-of-way to its original conditions existing before the construction or installation of the encroachment, to the satisfaction of the City Engineer and all at the sole expense of the Permittee.
- 9. This agreement and the associated permit for an encroachment shall become effective upon tiling of this agreement with the Alameda County Recorder for recordation as an encumbrance of the property and hs title.
- 10. The Permittee acknowledges that the City makes no representations or warranties as to the conditions beneath said encroachment. By accepting this revocable permit, Permittee agrees that it will use the encroachment area at its own risk, is responsible for the proper coordination of its activities with all other permittees, underground utilities, contractors, or workmen operating, within the encroachment area and for the safety of itself and any of its personnel in connection with its entry under this revocable permit.
- 11. The Permittee acknowledges that the City is unaware of the existence of any hazardous substances beneath the encroachment area, and Permittee hereby waives and fully releases and forever discharges the City and its officers, directors, employees, agents, servants, representatives, assigns and successors from any and all claims, demands, liabilities, damages, actions, causes of action, penalties, tines, liens, judgments, costs, or expenses whatsoever (including, without limitation, attorneys' fees and costs), whether direct or indirect, known or unknown, foreseen or unforeseen, that may arise out of or in any way connected with the physical condition or required remediation of the excavation area of any law or regulation applicable thereto, including, without limitation, the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended (42 U.S.C. Sections 9601 et seq.), the Resource Conservation and Recovery Act of 1976 (42 U.S.C. Section 466 et seq.), the Safe Drinking Water Act (14 U.S.C. Sections 1401, 1450), the Hazardous Waste Control Law (California Health and Safety Code Sections 25100 et seq.), the Porter-Cologne Water Quality Control Act (California Health and Safety Code Section 13000 et seq.), the Hazardous Substance Account Act (California Health and Safety Code Sections 253000 et seq.), and the Safe Drinking Water and Toxic Enforcement Act (California Health and Safety Code Section 25249.5 et seq.).
- 12. The Permittee further acknowledges that it understands and agrees that it hereby expressly waives all rights and benetits which it now has or in the future may have, under and by virtue of the terms of California Civil Code Section 1542, which reads as follows: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR." The Permittee recognizes that by waiving the provisions of this section, Permittee will not be able to make any claims for damages that may exist, and to which, if known, would materially affect its decision to agree to these encroachment terms and conditions, regardless of whether Permittee's lack of knowledge is the result of ignorance, oversight, error, negligence, or any other cause.
- 13. The Permittee shall, and by the acceptance of this revocable permit agrees and promises:
 - (a) to indemnify, defend, save and hold harmless the City of Oakland, its officers, agents,

employees, and volunteers, to the maximum extent permitted by law, from any and all suits, claims, demands, liabilities, damages, actions, causes of action, penalties, tines, liens, ijudgments, costs, or expenses whatsoever (including, without limitation, attomeys' fees and costs) (collectively referred to as "claims"), whether direct or indirect, known or unknown, foreseen or unforeseen, brought by any person for or on account of any bodily injuries, disease or illness or damage to persons and/or property sustained or arising in the construction of the work performed under the permit or arising out of the Permittee's failure to perform the obligations with respect to the use and occupancy of the public right-of-way by virtue of the permit, to the extent that such claims were either (1) caused by the Permittee, its agents, employees, contractors or representatives, or (2) in the case of environmental contamination, the claim is a result of environmental contamination that emanates or emanated from 275 West MacArthur Boulevard and/or 3600 Broadway, Oakland, Califomia site, or was otherwise caused by the Permittee, its agents, employees, contractors or representatives; and

- (b) if any contamination is discovered below or in the immediate vicinity of the encroachment, and the contaminants found are of the type used, housed, stored, processed or sold on or from 275 West MacArthur Boulevard and/or 3600 Broadway, Oakland, California site, such shall amount to a rebuttable presumption that the contamination below, or in the immediate vicinity of, the encroachment was caused by the Permittee, its agents, employees, contractors or representatives; and
- (c) the Permittee shall comply with all applicable federal, state, county and local laws, rules, and regulations governing the installation, maintenance, operation and abatement of the encroachment.
- 14. The encroachment permit and accompanying indenture agreement shall take effect when all the conditions hereinabove set forth shall have been complied with to the satisfaction of the City Engineer, and shall become null and void upon the failure of the Permittee to comply with all conditions.
- 15. The Indenture Agreement alone does not allow work to be done which requires permitting and/or inspection, and the Permittee shall obtain any and all required permits before beginning work.
- 16. The hereinabove conditions shall be binding upon the Permittee and the successive owners and assigns thereof; and be it

FURTHER RESOLVED: That the City Council of the City of Oakland, at hs sole discretion and at a future date not yet determined, may impose additional and continuing fees as prescribed in the Master Fee Schedule, for use and occupancy of the public right-of-way; and be it

FURTHER RESOLVED: That this resolution shall take effect when all the conditions hereinabove set forth have been complied with to the satisfaction of the City Engineer and shall become null and void upon the failure of the Permittee to comply with the conditions hereinabove set forth after notice and failure to cure such conditions in a reasonable manner; and be it






EXHIBIT C (1 of 6)

Encroachment Key Plan




EXHIBIT C (2 of 6)

Detail 1 - Transformer Vault and Telecommunications Conduit Encroachments




EXHIBIT C (3 of 6)

Detail 2 - Transformer Vaults Encroachment






Detail 5 - Transformer Vault Encroachments





















