RECOMMENDATION

Staff recommends that the City Council adopt:

An Ordinance Amending Municipal Code Sections 2.16.010 And 3.04.020, Redefining And Establishing The 2014 City Council And School Board District Boundaries Of The City Of Oakland (Redistricting).

OUTCOME

Adoption of this Ordinance will result in the submittal of the new district boundary lines to the Alameda County Registrar of Voters, for use prior to the next City of Oakland district elections.

BACKGROUND

At the October 29, 2013 City Council hearing on redistricting, the Council heard from 20 public speakers, and approved a motion for redistricting map #26 to represent the 2014 City Council and Oakland Unified School Board boundaries (see *Attachment A*).

The City's redistricting adoption process included public workshops in each of the seven Council districts, numerous presentations at neighborhood meetings, approximately 30 maps submitted by the public, and two Council hearings (October 15 and 29th).

With the motion on October 29th, the Council chose a redistricting map. Staff has incorporated the selected map into an ordinance for first reading at the Council hearing of November 19, 2013. Staff recommends adopting this ordinance. If approved, the second reading of the ordinance will be on **D**ecember 10th.

ANALYSIS

The map selected by Council, Map #26, was prepared by Councilmember Lynette Gibson McElhaney. There are a number of changes the map makes to the current boundaries:

- 1. Broadway Terrace is generally the new border between District 1 and District 4 (Forest Park neighborhood moves to District 4; Woodland Place, Pine Needle and Farralon Way move to District 1).
- 2. East of the Lake, Haddon Hill, Lakeshore Avenue from District 3 into District 2
- 3. "Gold Coast" neighborhood blocks bounded by Madison Street, Lake Merritt, 17th and 14th Streets from District 3 into District 2.
- 4. In the Glenview neighborhood, both sides of Trestle Glen Road are united into District 2; both sides of Greenwood Avenue and Canon Avenue are united into District 5.
- 5. Melrose neighborhood, between Seminary and 51st Avenue from International Blvd south to San Leandro Street and the railroad tracks, from District 6 into District 5
- 6. Maxwell Park neighborhood united into District 6, from being split between District 4 and District 6.
- 7. Two census blocks just west of Fruitvale Elementary School (not including the school itself), bordered by 1-580, Boston Ave, School Street, and Champion Street, move from District 4 to District 5.

The map also avoids making changes that were proposed on similar maps, but opposed by the neighborhoods involved:

- The Lower San Antonio neighborhood remains intact and in District 2;
- The neighborhood east of Hwy 24 and west of Broadway Terrace, around the North Oakland regional sports center remains in District 1;
- Adams Point remains united in District 3;
- The Jack London Improvement District remains united in District 3:
- Fremont High School remains in District 5;
- The neighborhood between Piedmont Ave and Oakland Avenue north of 1-580 remains in District 1;
- The Richmond Ave / "Glen Echo" neighborhood remains united in District 3:
- The Lions Creek Crossing / Coliseum Gardens / neighborhood between International Blvd and 1-880 remains in District 6



An Ordinance Amending Municipal Code Sections 2.16.010 And 3.04.020, Redefining And Establishing The 2014 City Council And School Board District Boundaries Of The City Of Oakland (Redistricting).

WHEREAS, Section 203 of the Charter requires the City Council to redefine the Council Districts of the City of Oakland in 1993 and every ten years thereafter; and

WHEREAS, the City Council has considered the matter of redefining the Council districts, and has considered the population of the City of Oakland as reflected in the United States 2010 Census, and hereby finds that changes in population require that the districts be redefined; and

WHEREAS, on June 4, 2013, the City Council unanimously adopted 84443 C.M.S., a resolution establishing criteria and guidelines for the 2013 City of Oakland Redistricting; and

WHEREAS, during July and September 2013, the City held seven community meetings, one in each of the City Council districts, to explain the redistricting process, hear comments from the public and provide information to assist the public in developing redistricting alternatives; and

WHEREAS, the City presented the redistricting process to the Oakland Unified School Board meeting of August 26, 2013, inviting their participation; and

WHEREAS, individuals and/or groups submitted twenty-eight redistricting map alternatives by October 15, 2013; and

WHEREAS, the City's Redistricting consultant, Doug Johnson of National Demographics Corporation, submitted proposed maps for the Council's consideration; and

WHEREAS, individual Councilmembers submitted proposed maps for the Council's consideration; and

WHEREAS, on October 15, 2013 the City Council held a public meeting to review the submitted maps, and directed the redistricting consultant to modify three of the maps; and

WHEREAS, at its meeting on October 29, 2013, the City Council listened to public comment and reviewed the mapping alternatives, including new maps submitted by Councilmembers, and by a vote of 6 to 1 directed staff to prepare an ordinance consistent with "Map 26," submitted by Councilmember Lynette Gibson McElhaney; and

WHEREAS, the approved map from October 29, 2013 makes the following changes to the 2003 District boundaries: Broadway Terrace is new boundary between District 1 and 4; Lakeshore Avenue and the east of the Lake neighborhood moves from District 3 to District 2; "Gold Coast" neighborhood blocks bounded by Madison Street, Lake Merritt, 17th and 14th Streets moves from District 3 into District 2; in the Glenview neighborhood, both sides of Trestle Glen Road are united into District 2; both sides of Greenwood Avenue and Canon Avenue are united into District 5; Melrose neighborhood, between Seminary and 51st Avenue from hitemational Blvd south to San Leandro Street and the railroad tracks, from District 6 into District 5; Maxwell Park neighborhood united into District 6, from being split between District 4 and District 6; two census blocks west of Fruitvale Elementary School (not including the school itself), bordered by 1-580, Boston Ave, School Street, and Champion Street, move from District 4 to District 5; and

WHEREAS, the City Council f nds that the proposed Council districts reflected in Map 26, as set forth in Exhibits A and B are composed of contiguous territory, are as equal as practicable in population as shown by the United States 2010 Census, are as geographically compact as practicable, and take into consideration the topography, geography, cohesiveness, contiguity, integrity, compactness of territory, the City Charter's requirement of preserving incumbents within their existing districts, and communities of interests; now, therefore,

THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

SECTION 1. The City Council finds and determines the forgoing recitals to be true and correct and hereby adopts and incorporates them into this Ordinance.

SECTION 2. The City of Oakland is hereby divided into seven Council districts, and the boundaries of the districts are more particularly depicted in Exhibit A and described in Exhibit B.

SECTION 3. The Municipal Code is hereby amended to add, delete, or modify sections as set forth below (section numbers and titles are indicated in **b**old type; additions are indicated by <u>underscoring</u> and deletions are indicated strike-through-type; portions of the ordinances not cited or not shown in underscoring or strike-through type are not changed. Municipal code section 2.16.010 is hereby amended as described in Exhibit A. Municipal code section 3.04.020 is hereby amended as described in Exhibit B.

A. District #1.

B. District #2.

Beginning at the intersection of Broadway and 1-880; thence proceeding northerly along Broadway to 14th Street; thence proceeding easterly along 14th Street to Madison St; thence proceeding northerly along Madison St to 17th Street; thence proceeding easterly along 17th St to Lakeside Dr; thence proceeding north along Lakeside Dr to the north end of Census Block 060014034001012, which is just northeast of the Essex Apartment building; thence proceeding easterly along the north end of Census Block 060014034001012 to the Lake; thence proceeding counter-clockwise around the Lake to the north end of Census Block 060014034001011, located where Lakeshore Drive turns south to go along the eastern side of Lake Merritt; thence proceeding easterly along the north end of Census Block 060014034001011 to the intersection of El Embarcadero and Lakeshore Drive; thence proceeding northwesterly along El Embarcadero to Grand Ave; thence proceeding northeasterly along Grand Ave to 1-580; thence proceeding northwesterly along Oakland Ave to

Beginning at the point of intersection of the City's eastern border and Skyline Blvd; thence proceeding westerly along Skyline Blvd to Broadway Terrace; thence proceeding southerly along Broadway Terrace to Pine Needle Drive; thence proceeding southerly and westerly along Pine Needle Drive to Farallon Way; thence proceeding southerly and westerly along Farallon Way to Broadway Terrace; thence proceeding westerly along Broadway Terrace to Warren Freeway; thence proceeding southerly along Warren Freeway to Moraga Avenue; thence proceeding westerly along Moraga Avenue to the Piedmont/Oakland city line; thence proceeding clockwise along the Piedmont/Oakland city line to Leimert Rd; thence proceeding easterly along Leimert Rd to Sausal Creek; thence proceeding southerly along Sausal Creek to Montana St; thence proceeding easterly along Montana St to Fruitvale Ave; thence proceeding southerly along Fruitvale Ave to 1-580; thence proceeding easterly along 1-580 to Boston Ave; thence proceeding southerly along Boston Ave to School St; thence proceeding easterly along School St to Peralta Creek; thence proceeding southerly along Peralta Creek to the southern border of Census Block 060014065001007, located between 2355 and 2300 Humboldt Ave; thence proceeding easterly along the southern border of Census Block 060014065001007 to Humboldt Ave; thence proceeding southerly along Humboldt Ave to Davis St; thence proceeding easterly along Davis St to 35th Ave; thence proceeding northerly along 35th Ave to Meadow St; thence proceeding easterly along Meadow St to Harrington Ave; thence proceeding northerly along Harrington Ave to Lyon Ave; thence proceeding easterly along Lyon Ave to Ransom Ave; thence proceeding southerly along Ransom Ave to Santa Rita St; thence proceeding easterly along Santa Rita St to High St; thence proceeding northerly along High St to Congress Ave: thence proceeding easterly along Congress Ave to 47th Ave; thence proceeding southerly along 47th Ave to Bancroft Ave; thence proceeding easterly along Bancroft Ave to 55th Ave; thence proceeding northerly along 55th Ave to Brookdale Ave; thence proceeding northwesterly along Brookdale Ave to High St; thence proceeding northerly along High St to 1-580; thence proceeding easterly along 1-580 to Warren Freeway, thence proceeding northerly along Warren Freeway to Mountain Boulevard; thence proceeding northerly along Mountain Boulevard to Redwood Road; thence proceeding easterly along Redwood Road to the Oakland city border; thence proceeding counter-clockwise along the City border to the point of beginning.
