- Brian Beveridge to serve a two-year term on the Community Jobs Oversight Commission as the OaklandWORKS Coalition representative beginning December 10, 2013 and ending December 9, 2015; and
- Joe Sarapochillo to serve a one-year term on the Community Jobs Oversight Commission
 as an Employer representative beginning December 10, 2013 and ending December 9,

- Megan Morodomi to serve a two-year term on the Community Jobs Oversight Commission as an Employer representative beginning December 10, 2013 and ending December 9, 2015; and
- Jens Hilmer to serve a one-year term on the Community Jobs Oversight Commission as the City representative beginning December 10, 2013 and ending December 9, 2014; and
- Mark Henderson to serve a two-year term on the Community Jobs Oversight Commission as the City representative beginning December 10, 2013 and ending December 9, 2015;
