RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF THE EIGHTH AMENDMENT TO THE OAKLAND-ALAMEDA COUNTY COLISEUM OAKLAND ATHLETICS AMENDED AND RESTATED STADIUM LICENSE AGREEMENT

WHEREAS, the Board of Commissioners of the Oakland Alameda County Coliseum Authority (the "Authority") has approved; and accepted the Eighth Amendment ("the Amendment") to the Oakland-Alameda County Coliseum Oakland Athletics Amended and Restated Stadium License Agreement (the "License Agreement"); and

WHEREAS, execution of the Amendment is a modification of the License Agreement; and

FURTHER RESOLVED: That all actions heretofore taken by the officers and agents of the Authority concerning the negotiations pertaining to the agreement reached as reflected in the Amendment are hereby approved, confirmed and ratified, and the City recommends that the Authority direct and authorize its proper officers, for and in the name and on behalf of the Authority, to do any and all things and take any and all actions and necessary to execute the Amendment, and other documents which they, or any of them, may deem necessary or advisable in order to effectuate the purposes of this resolution.
